



Dear Sir / Madam,


Good day! Pertaining to our complained submitted by my personal secretary, Michelle Miran Gajetoe, with PCC code N° WG-JTS-09-22-2022-032. Since our first report already more than 4 months Ago to malacanang presidential complaint asking to DENR to contradict the survey of Calapan DENR in order to accomplish the court order. I am thirsty to have true, legal an honest survey of our property. Nothing has changed positively the various departments of the DENR contenting themselves with sending their files between their departments to our opinion save time.

Despite of the payment of 150,000 pesos I've paid to DENR by my lawyer, that disapear into the air, nothing was done. All we want is to get justice and get an objective survey not from Mimaropa services, who are at faut in the wrong, rude and sloppy survey ingeneer Garcia has done: a stick was planted after an incomprehensible bifurcation of more than 4 meters to avoid the overhanging house of the defendant., moreover we have a survey carried out by a certified surveyor with the positions of more than 100 points were observed and who noticed 101,50 square meters encroachment on the ground! Of course this survey was carried out with the knowledge that is was likely to be producted in court.

Today half of the beyond granted by judge Rico has already passed. Could you please compel the DENR to carry out survey as soon as possible? Please correct us if we are wrong, because I have my instinct that the department is trying to protect someones interest. Please do a fair actions for this. I want any surveyor but not coming from regional office whom the Calapan DENR connected with. I lost trust already, I'm sorry for this. I have an appointment already to Senator Tulfo regarding this matter. Im running of time, our complain is since July 19,2022, and this case is already more than 3 years, waiting checking survey for 9 months, I understand what my personal secretary told me that this is culture of civil case in your country, but to manipulate the truth is not understandable. Soon will be our hearing, I hope you understand me. Please I am hoping for your immediate action regarding this matter.
