

Respectfully forwarded is the memorandum of CENRO Taytay, Palawan dated November 9, 2022 relative the above subject.

Per memorandum, the recovery/apprehension was made on June 8, 2022 at around 6:00 P.M. by the enforcement personnel of CENRO Taytay and ENTMRPA Forest Protection Officers with participation of Barangay Officials of Barangay Sibaltan while doing verification, surveillance and patrolling activities and found the piled of lumbers of Apitong forest tree species in the area of Sitio Bulwang, Barangay Sibaltan, El Nido, Palawan. No one seen within the vicinity during the recovery. Hence, the team concluded that the lumbers were abandoned.

The team apprehended the four (4) pieces (80 board feet) lumbers of Apitong species of with estimated fair market value of Php4,800.00. The subject abandoned lumbers were brought and deposited at Forest Products Monitoring Station V at New Ibajay, El Nido, Palawan for safekeeping purposes under the custody of Administrative Aide VI/CENRO Property Custodian Norie D. Pineda.


Notices to the public dated July 13, 2022, July 20, 2022 and July 27, 2022 were posted to different public places pursuant to DAO 1997-32. In spite of the three (3) consecutive notices posted on different conspicuous places, no claimant appeared before the CENR Office. Hence, absence of the owner/claimant to appear/claim shall be deemed a waiver of their rights to the apprehended item in favor of the government. Further, the notice of hearing dated October 4, 2022 was sent to all concerned parties and finally on October 17, 2022 the administrative hearing was conducted at DENR CENRO Taytay, Palawan.

We concur with CENRO recommendation for the issuance of confiscation order of the apprehended forest product in favor of the government.

This report is respectfully submitted pursuant to Department (DENR) Administrative Order 97-32 dated October 10, 1997.

**WHAT**

This is the final report on the administrative adjudication of the four (4) pieces of lumber of Apitong species equivalent to eighty (80) board feet.

**WHEN**

The interception/recovery took place last June 8, 2022 and the corresponding report was submitted and received in the Office on June 13, 2022 (Annex A to A<sub>1</sub>) plus the geo-tagged pictures (Annex B), and Tally Sheet (Annex C) and Apprehension Receipt (Annex D to D<sub>2</sub>).

**WHERE**

The forest products were recovered in Sitio Bulwang, Barangay Sibaltan, El Nido, Palawan and brought to Forest Product Monitoring Station V at New Ibajay, El Nido, Palawan.

**WHO**

The so-called Apprehension Receipts bear no name of probable culprits. The operating enforcers were personnel from the Forest Product Monitoring Station (FPMS) V composed of Forest Ranger Leo D. Tabernilla as Team Leader along with ENTMRPA Forest Protection Officers.

**WHY**

The subject items of forest products were taken and seized for failure by anybody to claim with valid documents despite invitation in public notice posted in three consecutive weeks.

**HOW**

The team conducted surveillance and foot patrol on June 8, 2022 when they noticed the four (4) pieces of Apitong lumber. They conducted surveillance and coordinated with the BLGU of Sibaltan regarding the abandoned lumber. The team seized and lumber and brought to Forest Product Monitoring Station V at New Ibajay, El Nido for safekeeping.

ADJUDICATION PROCEDURE

Seizure Receipt (E) and Seizure Order (Annex F to F<sub>2</sub>) and were facilitated on July 13, 2022 in order to acquire jurisdiction over the intercepted items. The seized items have an estimated value of four thousand eight hundred (4,800.00) pesos. Public notices (Pabatid sa Publiko) were posted consecutively every week on July 13, 20 and 27, 2022 (Annexes G to G<sub>2</sub>). The Certification of the Records Officer dated August 3, 2022 was then issued upon completion of the posting of Pabatid to the Public (Annex H).

In the absence of claimant, the undersigned opted to adjudicate the issue on the basis of the report submitted. This Office sent invitation to Forest Ranger Leo D. Tabernilla et. al, and Punong Barangay Arvin Q. Gabayan of Barangay Sibaltan, El Nido, Palawan to a hearing on 14<sup>th</sup> day of October, 2022 at 2:30 in the afternoon (Annex I to I<sub>1</sub>). The hearing was postponed since Forest Ranger Leo D. Tabernilla was still on the FPMS V, New Ibajay, El Nido, Palawan for official matter. It was then pushed through on the 17<sup>th</sup> of October, 2022 at 10:30 in the morning.

The examination pushed through as evidenced by the Attendance Sheet (Annex J). Preliminaries such as attendance check and the IEC presentation was set aside since all of the attendees were personnel from this Office.

On the examination, *Hearing Officer* directly asked the Apprehending Officer on the location on the lumber. *Forest Ranger Tabernilla* introduced himself being the Team Leader of FPMS V and answered that the lumber is now on the custody of FPMS V at New Ibajay, El Nido, Palawan. *HO* then questioned about the owner of the lumber and FR Tabernilla replied that on the day they found out the lumber, they coordinated with the BLGU of Sibaltan but the officials have no knowledge on the possible owner of the items, the team then declared the lumber as abandoned. Upon recommendation of the Apprehending Officer, the *HO* also declared the lumber as abandoned and adjourned the hearing.

Transcript of the minutes is Annex K to K<sub>1</sub>.

Conclusion and recommendation

The items listed down in the Seizure Order and Seizure Receipt are deemed abandoned thus hereby recommended for the issuance of Order of Forfeiture.



**WHAT**

This is the report of the apprehended abandoned four (4) pieces Apitong lumber with equivalent eighty (80) board feet at Sitio Bulwang, Brgy. Sibaltan, El Nido, Palawan.

**WHEN**

The apprehension took place last June 8, 2022 at around 6:00 in the afternoon and the corresponding report was submitted and received in the Office on June 13, 2022 along with the geotagged photos.

**WHERE**

The apprehension took place at Sitio Bulwang, Brgy. Sibaltan, El Nido, Palawan and the said apprehended forest product was brought to Forest Product Monitoring Station V, New Ibajay, El Nido, Palawan.

**WHO**

The owner of the said item is unidentified. The enforcement personnel were representing our Forest Product Monitoring Station V namely Forest Ranger Leo D. Tabernilla, Forest Protection Officers Bryan C. Casiple, Milbert Cariño, Jayrone Sta. Rosa and Rolando Inguanzo.

**WHY**

The said forest product was taken and seized in violation to Section 77 of Presidential Decree 705 as amended otherwise known as Revised Forestry Code of the Philippines as stated as "Any person who shall cut, gather, collect, or remove timber or other forest product from any forest land, or timber from alienable or disposable public lands, or from private lands, without any authority, OR POSSESS TIMBER OR OTHER FOREST PRODUCTS WITHOUT THE LEGAL DOCUMENTS AS REQUIRED UNDER EXISTING FOREST LAWS AND REGULATIONS, SHALL BE PUNISHED WITH THE PENALTIES IMPOSED shall be guilty of qualified theft as defined and punished under Article 309 and 310 of the Revised Penal Code.

## HOW
