
A total of three (3) resolutions were passed numbered from MGGNP-PAMB En Banc resolution No. 2022-13 to 2022-15; to wit:

| I. Preliminaries A. Invocation & Singing of National Anthem B. Welcome Address | <p>The 4th PAMB En Banc Meeting for CY 2022 of Mt. Guiting-Guiting Natural Park (MGGNP) was opened with an invocation with the aid of an Audio Visual Presentation (AVP) then followed by singing the Philippine National Anthem lead by EcoMS I Mylene Evallar.</p> <p>Hon. Arthur R. Tansiongco, M.D., Municipal Mayor of Magdiwang gave his welcome address for the 4th Quarter MGGNP PAMB En Banc meeting. He welcomed the PAMB Members and stated his gladness for sparing their time and effort to attend the 4th Quarter PAMB En Banc meeting of MGGNP. He also thanked and welcomed the Barangay Captains who are members of the PAMB for travelling to Magdiwang to attend the Meeting even through the rainy weather. He also expressed his welcome to PASu Manuel B. Romero for attending his first PAMB Meeting as PASu of MGGNP after a very long time, and remembered the past decades where he and PASu Romero passionately worked for the protection of MGGNP.</p> <p>Ms. Darryl Perez, Municipal Planning and Development Officer (MPDO) of San Fernando, and representative of Hon. Tansiongco gave a short message. She stated that she was glad that she was chosen to represent the Hon. Mayor Nanette B. Tansiongco and assured that she shares the passion in protecting Mt. | <p>II. Meeting Proper</p> <p>A. Introduction of PAMB En Banc Members, DENR Staff and Secretariat</p> | <p>Then, PASu Manuel B. Romero gave a short message. First, he acknowledged the PAMB Members present during the meeting. He stated his gladness as it was his first PAMB En Banc Meeting since he assumed the position as OIC Sibuyan Sub-Station and PASu of Mt. Guiting-Guiting Natural Park last September. PASu Romero also told on how in the previous time, he and Hon. Tansiongco shared the efforts in protecting and conserving MGGNP on his time as PASu. He expressed gladness to see familiar faces that had joined him in the past in the endeavor of protecting MGGNP and much more gladness to see many new faces since it is an indicator that there are more and more people committed to protecting the Protected Area. He added that this time, he will once again exert effort and passion to do the same. He also shared the good news of procuring the vehicle from IPAF Fund through the effort and perseverance of then PASu Malvin R. Rocero. He shared that the vehicle is already delivered on the PENR Office and will soon be delivered in Sibuyan Island hopefully before the end of the year.</p> <p>EcoMS I Nieves F. Blaza, Jr., National Agencies representative, Academe, NGOs and POs, IP Representative, Barangay Officials from the seventeen (17) barangays, Protected Area Management Office (PAMO) staff, members of the secretariat, guests and visitors.</p> | |

| Approval of the Minutes of the Previous Meeting (May 18, 2022) | <p>Since the Regional Executive Director and PAMB Chairperson, Lormelyn E. Claudio, CESO IV was not able to attend the meeting due to his busy schedule and attendance to equally important matters in Palawan; hence, in the absence of the chairman, Rule 11.6 of the NIPAS Act shall prevail which state that “the members by highest number of votes of those in attendance, shall choose from among themselves a presiding officer,” so, EcoMS I Penuliar opened the floor for nomination of presiding office for the 4th Quarter PAMB En Banc meeting. Hon. Ramona Rivero nominated Hon. Arthur R. Tansiongco, Municipal Mayor of Magdiwang. Hon. Ireen Roa moved to close the nomination, it was seconded by Hon. Ramonito Gubaton and duly approved by the majority members of the PAMB. Hon. Arthur R. Tansiongco was unanimously appointed to be the presiding officer for the 4th Quarter PAMB En Banc Meeting.</p> <p>The presiding officer asked the Board if there are any comments, suggestions or objections on the minutes of previous meeting. The PAMB Members were given copies of the minutes before hand for their review and reference.</p> <p>During the reading of minutes, Hon. Jesse B. Roda raised a query on the status of membership of Bayay Sibuyanon and if the meeting was allowed to be attended by two (2) personnel for one (1) NGO since last meeting, he observed that both Hon. Elizabeth and Hon. Galicia were present during the meeting. Hon. Tansiongco answered that in the previous meetings, Hon. Ibañez had been the alternate of Hon. Galicia since he was not permanently residing in Sibuyan during the pandemic. Hon. Maryjane Rocero added that during the last quarter meeting, Hon. Ibañez attended the meeting because Hon. Galicia was in another meeting and cannot attend the MGGNP PAMB Meeting on time and he arrived only after the discussion of agenda. Chief, TSD Malvin R. Rocero then stated that it is alright to have two representatives during the meeting but they will only get one voting power.</p> <p>After the reading of the minutes, Hon. Tansiongco asked if there are other comments, suggestions, or objections. Since there were no comments and objections from the 3rd Quarter PAMB En Banc minutes, Hon. | <p>G. Meeting Agenda</p> <p>1. Reporting of LAWIN and Forest Protection and Law Enforcement</p> | <p>Forester I Rolly Morales reported the updates for LAWIN patrolling and foot patrolling within the proposed buffer zones and inside MGNP from August 24, 2022 to November 07, 2022. A total of 14.67 kilometres of patrol tracks were recorded by LAWIN patrollers including Forest Rangers, Forest Technicians and other Forest Protection Officers, Park Rangers and LGU Rangers from August 24, 2022 to November 07, 2022, totaling to 403.07kms patrolled. He reported that Park Rangers and DENR permanent patrollers conducted regular patrolling in the area of Mt. Guiting-Guiting Natural Park and its proposed bufferzone/timberland. There are some illegal cutting of trees recorded by the patrollers while patrolling in the Forestland/Timberland. Patrollers conducted the recording of stumps in the area for database. He also showed the areas where some of the apprehension happened.</p> | <p>Hon. Samson Romero and approved by the majority members of the PAMB.</p> | |
| <p>2. Presentation of 2nd Semester Biodiversity Monitoring System</p> | <p>EcoMS I Mylene Evallar presented the 2nd semester report of BMS to the Board. She explained the objectives behind Biodiversity Monitoring System which it is designed by DENR to improve the information available for decision-makers in Protected Areas through the regular collection of data on natural resources and their utilization. The focus of BMS is to identify the trends in biodiversity and its use to guide the actions of PAMB board members and their decisions. BMS also aims to improve the participation of IP's and other communities in resource management and protection, in close collaboration with the PA staff. She also presented the Field Diary conducted by the BMS Team whereas the data recorded regarding the routine observation on resources were stated. The first issue is the Illegal cutting of Trees (Post, lumbers and poles) within the Timberland/Protected Area for wood charcoal making, production of furniture, and secondly is the Unregistered Power Chainsaw that operates in some parts of Sibuyan Island were the main issues discussed on the presentation. EcoMS I Evallar then presented the Recommended PAMB Action namely;</p> <p>a) Intensification and strict enforcement of P.D. 705, NIPAS Act, Wildlife Act, and R.A.</p> | | |

| | <p>9175, b) Continuous linkages to other law enforcement agencies such as PNP, PCG and Philippine Army to support in intelligence, surveillance and apprehension of involved persons in illegal cutting of trees, c) deployment of additional Forest/Park Rangers to manned the island forest cover, d) Provision of service firearms for DENR Forest Patrollers, e) Encourage LGUs and private land owners to develop tree plantation as future source of lumbers/timbers, f) Offset schedule of forest patrollers during holidays and weekends, g) Intensify CEPA activities in the problem areas. Then, EcoMS I Evallar asked the Board if there are any additional PAMB action they wish to include. Hon Tansiongco stated that the three LGUs should further encourage the private land owners to develop tree plantation as future source of lumber/timbers for the following years. PASu Romero agreed to this idea because it will avoid the sourcing of lumber/timber from Timberland and Protected Area. Hon. Joven Rodeo of Brgy. Dulangan, Magdiwang asked if the DENR Sibuyan Sub-Station Office could provide the updated list of registered chainsaw operators in Sibuyan Island for the reference of Brgy. Captains. This is to ensure that they will only allow the registered chainsaw to operate in their barangay and will help minimize illegal cutting of trees. PASu Romero took note of this suggestion and stated that he will immediately provide a copy of updated registered chainsaw operators for the barangays.</p> <p>Hon. Geneva Rosas then raised the issue on the requirements for the issuance of Tree Cutting Permit. She explained that some individuals had difficulty in applying of tree cutting permit because they do not have a land title that is one of the requirements. PASu Romero encouraged the Board to inform the Public that DENR had a Free Patent Drive. Whereas, individuals could apply for land titles for free and DENR personnel will assist them during the process of application. PASu Romero also added that the DENR will extend necessary help during the process. Hon. Ireen Roa raised her hand and shared one of the experiences she had in their community. She explained that some IP members in their community continue to conduct illegal activities because they do not have any alternative source of income. Thus she decided to provide them a job of being tenants in some of their land. She explained that the person was allowed to cultivate the land and harvest its crops (copra) and thankfully the person did not commit any illegal act since then. She explained that this incident proves that sometimes, people should also be given second chances. Hon. Tansiongco agreed with this statement as some people commits illegal activities because they do not have livelihood or source of income and that as public officials, we could always extend a helping hand. Chief, TSD Malvin R. Rocero shared that there had been plans to conduct training for guides and porters for CY 2023 in preparation to the formal opening of the trail at Brgy. Lumbang Weste, Cajidiocan. He further stated that the</p> | |



Tansiongco agreed to this and stated that next time, the Board should also invite the MPDOs of the three municipalities to be observers/guests during PAMB Meetings. PASu Romero agreed as well and instructed the secretariat to take note of the suggestion. Then, Hon. Radan continued his sentiment that since EcoMS II Rebecca M. Delgado (designated Special Collecting Officer) had been assigned in PENR Office, Odiongan, Romblon as Unit Head of Coastal and Marine Ecosystem Rehabilitation, issuance of receipt could not be done immediately. He also explained that it would be also better if payment of mountaineering fees could be done through cashless payment. For PAMB members who were in Sibuyan Island, the meeting was held in Magdiwang Public Plaza, Magdiwang, Romblon while PAMB members who were not in Sibuyan Island during the meeting participated via Zoom.

Time started: 9:45 a.m.

I. PRELIMINARIES

The 4th PAMB En Banc Meeting for CY 2022 of Mt. Guiting-Guiting Natural Park (MGGNP) was opened with an invocation with the aid of an Audio Visual Presentation (AVP) then followed by singing the Philippine National Anthem lead by EcoMS I Mylene Evallar.

EcoMS I Nieves F. Penuliar first acknowledged the presence of representatives of MIMAROPA Regional Executive Director, Lormelyn E. Claudio, CESO IV, the Mayor of Magdiwang, representative of the Mayor of San Fernando, Chief, Technical Services Division Malvin R. Rocero, and OIC PENR Officer Arnoldo A. Blaza, Jr., National Agencies representative,

Academe, NGOs and POs, IP Representative, Barangay Officials from the seventeen (17) barangays, Protected Area Management Office (PAMO) staff, members of the secretariat, guests and visitors.

Hon. Arthur R. Tansiongco, M.D., Municipal Mayor of Magdiwang gave his welcome address for the 4th Quarter MGGNP PAMB En Banc meeting. He welcomed the PAMB Members and stated his gladness for sparing their time and effort to attend the 4th Quarter PAMB En Banc meeting of MGGNP. He also thanked and welcomed the Barangay Captains who are members of the PAMB for travelling to Magdiwang to attend the Meeting even through the rainy weather. He also expressed his welcome to PASu Manuel B. Romero for attending his first PAMB Meeting as PASu of MGGNP after a very long time, and remembered the past decades where he and PASu Romero passionately worked for the protection of MGGNP.

Ms. Darryl Perez, Municipal Planning and Development Officer (MPDO) of San Fernando, and representative of Hon. Tansingco gave a short message. She stated that she was glad that she was chosen to represent the Hon. Mayor Nanette B. Tansingco and assured that she shares the passion in protecting Mt. Guiting-Guiting Natural Park.

Then, PASu Manuel B. Romero gave a short message. First, he acknowledged the PAMB Members present during the meeting. He stated his gladness as it was his first PAMB En Banc Meeting since he assumed the position as OIC Sibuyan Sub-Station and PASu of Mt. Guiting-Guiting Natural Park last September. PASu Romero also told on how in the previous time, he and Hon. Tansiongco shared the efforts in protecting and conserving MGGNP on his time as PASu. He expressed gladness to see familiar faces that had joined him in the past in the endeavor of protecting MGGNP and much more gladness to see many new faces since it is an indicator that there are more and more people committed to protecting the Protected Area. He added that this time, he will once again exert effort and passion to do the same. He also shared the good news of procuring the vehicle from IPAF Fund through the effort and perseverance of then PASu Malvin R. Rocero. He shared that the vehicle is already delivered on the PENR Office and will soon be delivered in Sibuyan Island hopefully before the end of the year.

Unfortunately, Regional Executive Director and PAMB Chairperson, Lormelyn E. Claudio, CESO IV, wasn't able to attend the 4th Quarter PAMB En Banc meeting because she was currently in a field work in Palawan. The Protected Area Management and Biodiversity Conservation Section staff, Ms. Fatima Grate participated the meeting on her behalf as observer and resource person.

II. MEETING PROPER

A. Introduction of PAMB En Banc Members, DENR Staff and Secretariat

EcoMS I Nieves F. Penuliar acknowledged the presence and introduced representatives of MIMAROPA Regional Executive Director, Lormelyn E. Claudio, CESO IV, the Mayor of Magdiwang, representatives of the Mayor of San Fernando, Chief, Technical Services Division Malvin R. Rocero, and OIC PENR Officer Arnoldo A. Blaza, Jr., National Agencies representative, Academe, NGOs and POs, IP Representative, Barangay Officials from the seventeen (17) barangays, Protected Area Management Office (PAMO) staff, members of the secretariat, guests and visitors.

B. Roll call and Call to Order

EcoMS I Nieves F. Penuliar officially roll-called the attendance of PAMB members from the Regional Office, Offices of the Congressman and Governor, the three (3) Municipal Mayors (Cajidiocan, Magdiwang and San Fernando), Department Heads of National Government Agencies, Non-Government Organizations, Peoples Organizations, Brgy. Local Government Units, Academe and Indigenous Peoples. Out of thirty-five (35) regular PAMB En banc members, twenty (20) were present; hence, a quorum was declared.

C. Reading and approval of the minutes of the previous meeting (August 23, 2022)

The Regional Executive Director and PAMB Chairperson, Lormelyn E. Claudio, CESO IV was not able to attend the meeting due to her busy schedule and attendance to equally important matters in Palawan; hence, in the absence of the chairman, Rule 11.6 of the NIPAS Act shall prevail which states that “the members by highest number of votes of those in attendance, shall choose from among themselves a presiding officer,” therefore, EcoMS I Penuliar opened the floor for nomination of presiding office for the 4th Quarter PAMB En Banc meeting. Hon. Ramona Rivero nominated Hon. Arthur R. Tansiongco, Municipal Mayor of Magdiwang. Hon. Ireen Roa moved to close the nomination, it was seconded by Hon. Ramonito Gubaton and duly approved by the majority members of the PAMB. Hon. Arthur R. Tansiongco was unanimously appointed to be the presiding officer for the 4th Quarter PAMB En Banc Meeting.

The presiding officer asked the Board if there are any comments, suggestions or objections on the minutes of previous meeting. The PAMB Members were given copies of the minutes before hand for their review and reference.

During the reading of minutes, Hon. Jesse B. Roda raised a query on the status of membership of Bayay Sibuyanon and if the meeting was allowed to be attended by two (2) personnel for one (1) NGO since last meeting, he observed that both Hon. Elizabeth and Hon. Galicia were present during the meeting. Hon. Tansiongco answered that in the previous meetings, Hon. Ibañez had been the alternate of Hon. Galicia since he was not permanently residing in Sibuyan during the pandemic. Hon. Maryjane Rocero added that during the last quarter meeting, Hon. Ibañez attended the meeting because Hon. Galicia was in another meeting and cannot attend the MGGNP PAMB Meeting on time and he arrived only after the discussion of agenda. Chief, TSD Malvin R. Rocero then stated that it is alright to have two representatives during the meeting but they will only get one voting power.

After the reading of the minutes, Hon. Tansiongco asked if there are other comments, suggestions, or objections. Since there were no comments and objections from the 3rd Quarter PAMB En Banc minutes, Hon. Maryjane Rocero moved for the approval of the minutes of the previous meeting, it was seconded by Hon. Jesse Roda and duly approved by the majority members of the PAMB.

D. Matters arising from the previous meeting

Hon. Arthur R. Tansiongco announced to proceed to PASu report on the agreement reached during the previous meeting.

E. Report of the Protected Area Superintendent (PASu) on the agreement reached during previous meeting on August 23, 2022

PASu Manuel B. Romero reported that the following resolutions numbered from MGGNP-PAMB En Banc Resolution No. 2022-08 to 2022-12 and minutes of the previous meeting dated August 23, 2022 were submitted to the Regional Executive Director/PAMB Chairperson for approval, thru the PENRO:

1. **PAMB Resolution No. 2022-08, S. of 2022 “A resolution enhancing the Patrolling System against illegal forest activities in the Protected Area, Timberland, and beyond the proposed Buffer Zones through using/installation of Earth Ranger Application and Installation of Outpost in the boundary of Brgy. Silum and Cantagda”;**
2. **PAMB Resolution No 2022-09 S. 2022, “A resolution to identify a common area of every LGU as Municipal Production Forest in accordance to FLUP and CLUP and**

enhancement of already established programs of every LGU relating to tree planting/growing”;

3. PAMB Resolution No. 2022-10 “A resolution adopting the renewal of Memorandum of Agreement with the three (3) LGUs of Sibuyan Island (Magdiwang, Cajidiocan, and San Fernando) for CY 2023 for the protection and conservation maintenance of Mt. Guiting-Guiting Natural Park amounting to Php 500,000.00”;
4. PAMB Resolution No. 2022-11 “A Resolution Requesting the Provincial Government of Romblon on a financial commitment for the Protection and conservation of Mt. Guiting-Guiting Natural Park”;
5. PAMB Resolution No. 2022-12, S. 2022 “A resolution strengthening the active monitoring of the PAMB on any activity related to mining to ensure the protection of Mt. Guiting-Guiting and Environment and Natural Resources in Sibuyan, Romblon”;

F. Approval of the Agenda

Hon. Arthur R. Tansiongco, then asked the Board if there are any additional agenda other than the four (4) agenda presented to be discussed in the meeting. Hon. Jhonny D. Riano moved for the approval of the agenda, it was seconded by Hon. Samson Romero and approved by the majority members of the PAMB.

G. Meeting Agenda

1. Reporting of LAWIN and foot patrolling within the proposed buffer zones and inside Mt. Guiting-Guiting Natural Park

Forester I Rolly Morales reported the updates for LAWIN patrolling and foot patrolling within the proposed buffer zones and inside MGGNP from August 24, 2022 to November 07, 2022. A total of 14.67 kilometres of patrol tracks were recorded by LAWIN patrollers including Forest Rangers, Forest Technicians and other Forest Protection Officers, Park Rangers and LGU Rangers from August 24, 2022 to November 07, 2022, totaling to 403.07kms patrolled. He reported that Park Rangers and DENR permanent patrollers conducted regular patrolling in the area of Mt. Guiting-Guiting Natural Park and its proposed bufferzone/timberland. There were some illegal cutting of trees recorded by the patrollers while patrolling in the Forestland/Timberland. Patrollers conducted the recording of stumps in the area for database. He also showed the areas where some of the apprehension happened.

2. Reporting of Barangay Captains on the status of illegal activities inside the Protected Area in their respective jurisdictions;

Hon. Tansingco then asked the Barangay Captains to proceed on the reporting of illegal activities within their jurisdiction. Hon. Salvador Mutia of Agsao, Hon. Samson Romero of Agutay, Hon. Dennis Riano of Jao-asan, Magdiwang reported that there are no illegal activities in their jurisdiction. Then, Hon. Maryjane Rocero of Brgy. Cantagda gave an update on the passed PAMB Resolution regarding the installation of outpost in the boundaries of Brgy. Cantagda, Cajidiocan and Brgy. Silum, Magdiwang. She stated that the outpost will minimize the illegal activities in their area. Hon. Tansingco asked Hon. Rocero of Cantagda regarding the use of manpower for the planned installation of outpost in the boundary of Cantagda and Silum. Hon. Rocero answered that they will have a Bayanihan system during the installation. Hon. Tansingco assured that he will provide assistance during the installation of outpost and reached for Hon. Ramos’ assistance as well. Hon. Joylene Ramiro then reported that there were no illegal activities in Brgy. Lumbang Weste, Cajidiocan. Hon. Jesse Roda of Brgy. Mabini, San Fernando reported that he had received reports that there are some illegal fanning (small scale mining) in his barangay and asked if DENR could provide assistance. PASu Manuel B. Romero answered the he will immediately dispatch DENR personnel to conduct monitoring and investigation regarding the matter.

3. Presentation of 2nd Semester Biodiversity Monitoring System (BMS)

EcoMS I Mylene Evallar presented the 2nd semester report of BMS to the Board. She explained the objectives behind Biodiversity Monitoring System which was designed by DENR to improve the information available for decision-makers in Protected Areas through the regular collection of data on natural resources and their utilization. The focus of BMS is to identify the trends in biodiversity and its use to guide the actions of PAMB board members and their decisions. BMS also aims to improve the participation of IP's and other communities in resource management and protection, in close collaboration with the PA staff. She also presented the Field Diary conducted by the BMS Team whereas the data recorded regarding the routine observation on resources were stated. The first issue is the Illegal cutting of trees (post, lumbers and poles) within the Timberland/Protected Area for wood charcoal making, production of furniture, and secondly is the Unregistered Power Chainsaw that operates in some parts of Sibuyan Island were the main issues discussed on the presentation. EcoMS I Evallar then presented the recommended PAMB Action namely; a) intensification and strict enforcement of P.D. 705, NIPAS Act, Wildlife Act, and R.A. 9175, b) continuous linkages to other law enforcement agencies such as PNP, PCG and Philippine Army to support in intelligence, surveillance and apprehension of involved persons in illegal cutting of trees, c) deployment of additional Forest/Park Rangers to manned the island forest cover, d) provision of service firearms for DENR Forest Patrollers, e) encourage LGUs and private land owners to develop tree plantation as future source of lumbers/timbers, f) offset schedule of forest patrollers during holidays and weekends, g) intensify CEPA activities in the problem areas. Then, EcoMS I Evallar asked the Board if there are any additional PAMB action they wish to include. Hon Tansiongco stated that the three LGUs should further encourage the private land owners to develop tree plantation as future source of lumber/timbers for the following years. PASu Romero agreed to this idea because it will avoid the sourcing of lumber/timber from Timberland and Protected Area. Hon. Joven Rodeo of Brgy. Dulangan, Magdiwang asked if the DENR Sibuyan Sub-Station Office could provide the updated list of registered chainsaw operators in Sibuyan Island for the reference of Brgy. Captains. This is to ensure that they will only allow the registered chainsaw to operate in their barangay and will help minimize illegal cutting of trees. PASu Romero took note of this suggestion and stated that he will immediately provide a copy of updated registered chainsaw operators for the barangays.

Hon. Geneva Rosas then raised the issue on the requirements for the issuance of Tree Cutting Permit. She explained that some individuals had difficulty in applying of tree cutting permit because they do not have a land title that is one of the requirements. PASu Romero encouraged the Board to inform the Public that DENR had a Free Patent Drive. Whereas, individuals could apply for land titles for free and DENR personnel will assist them during the process of application. PASu Romero also added that the DENR will extend necessary help during the process. Hon. Ireen Roa raised her hand and shared one of the experiences she had in their community. She explained that some IP members in their community continue to conduct illegal activities because they do not have any alternative source of income. Thus she decided to provide them a job of being tenants in some of their land. She explained that the person was allowed to cultivate the land and harvest its crops (copra) and thankfully the person did not commit any illegal act since then. She explained that this incident proves that sometimes, people should also be given second chances. Hon. Tansiongco agreed with this statement as some people commits illegal activities because they do not have livelihood or source of income and that as public officials, we could always extend a helping hand. Chief, TSD Malvin R. Rocero shared that there had been plans to conduct training for guides and porters for CY 2023 in preparation to the formal opening of the trail at Brgy. Lumbang Weste, Cajidiocan. He further stated that the Indigenous People are members of the Guides and Porters Association and the opening of the trails will provide an alternative source of income for the local community. Then, Hon. Ireen Roa moved to pass **PAMB Resolution No. 2022- 13 "A resolution requesting DENR and other government agencies to provide assistance and alternative livelihood to local communities to combat illegal activities and ease poverty"**. It was seconded by Hon. Johnny D. Riano and approved by the majority of the Board.

4. Finalization and Signing of the Memorandum of Agreement of the Three LGUs

After the thorough review of the Memorandum of Agreement between DENR PAMB and the three LGUs, Hon. Tansingco spearheaded the signing of MOA for LGU Magdiwang. He reiterated that the commitment of the PAMB for the protection and conservation of MGGNP should never cease because Mt. Guiting-Guiting is the treasure of Sibuyan. The Memorandum of Agreement between DENR PAMB and the LGUs is an extension of that commitment.

6. Other matters

For the Other matters, Hon. Jesse Roda asked if aside from the financial assistance from the provincial government that was previously requested in the last meeting, the Board could request a dump truck from our beloved governor. Hon. Tansiongco agreed to this and stated that having a dump truck to be used solely for hauling apprehended forest products within Sibuyan Island will be beneficial to MGGNP because sometimes, the dump trucks of the LGUs are being used for other official business. He further stated that it should be the Board's initiative to request the vehicle from the Provincial Government since our beloved Governor is also a member of the PAMB. Thus, Hon. Jesse Roda moved to pass **PAMB Resolution No. 2022-14, "A resolution requesting the Provincial Government of Romblon for one (1) dump truck that will be used for hauling of apprehended forest products within Sibuyan Island,"** it was seconded by Hon. Jhonny D. Riano and approved by the majority of the Board.

Hon. Rommel Augustus Radan then wished to be recognized. He took the opportunity to share MGGNP's one source of income which is ecotourism, particularly mountaineering – LGU Magdiwang has started collecting ecotourism fee for every tourist that visits the municipality. He further explained that they had a dialogue with the local tricycle operators/drivers, guides and porters that every tourist that arrives in Magdiwang should pay the ecotourism fee since the LGU had already passed a resolution last CY 2015 and they are implementing it once again since the we are now transitioning to new normal. He further stated that this practice could be done in San Fernando and Cajidiocan as well. He then expressed that since Ms. Darryl Perez, the MPDO of San Fernando was at the meeting, it was a great opportunity to share those kinds of programs. Ms. Darryl Perez agreed to this since they are also in charge of planning and developing their municipality. Hon. Tansiongco agreed to this and stated that next time, the Board should also invite the MPDOs of the three municipalities to be observers/guests during PAMB Meetings. PASu Romero agreed as well and instructed the secretariat to take note of the suggestion. Then, Hon. Radan continued his sentiment that since EcoMS II Rebecca M. Delgado (designated Special Collecting Officer) had been assigned in PENR Office, Odiongan, Romblon as Unit Head of Coastal and Marine Ecosystem Rehabilitation, issuance of receipt could not be done immediately. He also explained that it would be also better if payment of mountaineering fees could be done through cashless payment. However, at present, it would be better if the Board could allow the issuance of cash ticket to every mountaineer as the official receipt cannot be issued yet. Thus, Hon. Radan moved to pass **PAMB Resolution No. 2022-15, "A resolution requesting the DENR MIMAROPA Regional Executive Director to allow the issuance of cash ticket for ecotourism activities within Mt. Guiting-Guiting Natural Park",** it was seconded by Hon. Maryjane Rocero and approved by the majority of the Board.



H. Adjournment





WHEREAS, it is within the powers, duties and functions of the Protected Area Management Board (PAMB) to approve policies, guidelines, plans and programs, proposals, agreements and other related documents, including the Manual of Operation for the efficient and effective management of Mt. Guiting-Guiting Natural Park (MGGNP);

WHEREAS, during Phase-In Phase-Out of NIPAP held at Great Eastern Hotel in Manila the three (3) LGUs of Sibuyan Island (Cajidiocan, Magdiwang and San Fernando) committed to share financial support to sustain the protection, conservation and maintenance of Mt. Guiting-Guiting Natural Park;

WHEREAS, the termination of NIPAP project on September 2000 the limited resources coming from DENR Regular budget and the IPAF collection can no longer sustain the operation of the Protected Area Office to protect and preserved the biodiversity and integrity of Mt. Guiting-Guiting Natural Park;

WHEREAS, since CY 2008 - 2017 the three (3) LGUs are committed in the form of Memorandum of Agreement to allocate funds for the protection, conservation and maintenance of the park which was renewed every three (3) years;

WHEREAS, on August 23, 2022, during the PAMB En Banc meeting held at Magdiwang Public Plaza, Magdiwang, Romblon, it was raised to ask for an assistance from the Provincial Government for the protection, conservation, and maintenance of Mt. Guiting-Guiting Natural Park;

WHEREAS, the assistance could be provision of additional manpower to patrol the Protected Area and its proposed Buffer Zones, and formulation/development of projects geared towards the protection and conservation of MGGNP;

WHEREAS, during the 4th Quarter PAMB Meeting on November 08, 2022, the Board suggested to request one (1) dump truck to be used to haul apprehended forest products within Sibuyan Island;

WHEREAS, the dump trucks of LGU being used for apprehension sometimes is used for other official business and the DENR patrollers had difficulty in accessing vehicle to haul apprehended forest products;

WHEREAS, having a dump truck to be solely used by MGGNP-PAMO during apprehensions will greatly benefit the office when transporting the confiscated products;
