I remind you that we only want justice!

We are tired of waiting for your goodwill we have been moving your premises for several weeks and the decision is always posponed! It's a total lack of respect causing stress and anxiety an unnecessary expenses.

More generally, the DENR has been playing with our patient and our nerves for more than 2 years.

You can't imagine the damage DENR inflict on us!

On october 2019 we filed complaint, through my lawyer atty Ron Macalanda, against Spouses Roger A Gabat and Jocelyn Gabat for encroaching 2 parcels of my land.on fourth judicial region Branch 40 in Calapan Or Mindoro.

On november 24, 2020, the court issued an order directing the DENR-MIMAROPA to appoint a duly licensed geodetic engineer from their office to conduct a survey.

A surprise survey on 13 september 2021 without notice was carried out by Engr Garcia from DENR MIMAROPA.

8 months after the court order!

This survey and the report that followed it were found to be incorrect in our eyes.

This survey is wrong, rude an sloppy!

My accredited surveyor Mina Escalona stayed one week on site to conclude has an encroachment of more than 300 square meters!!

Following our legal action, Mr Gabat, the defendant, moved his barbed wire and gave me back more than 100 square meters. He then appealed to Mrs Moreno a person without right of title to carry out a survey totally wrong. We heard Mrs Moreno daughter work in DENR MIMAROPA. as engineer....

After a request the judge Charity Grace A Rico authorized us to carry out a control of this survey on november 2021

On March 4, my lawyer sent a letter to Benny Antiporda Usec from DENR NCR for verification survey.

Following this request, we were asked to send 50,000 pesos for logistics cost.

On march 14, 50;000 pesos were transferred (transaction number APM-11-78550-ZAW) threw pera padala to salvaddor Glori.employee of DENR NCR

After numerous contacts promising to carry out the survey, we were asked again for 100,000 pesos this time threw request no. NCR-2022-1845 by ENGR Gigi Tugno.from survey division DENR NCR.

On april 29 2022 Attorney Macalanda Came on DENR NCR to payed the 100,000 pesos. We have a signed receipt of this payment by ENGR Tugno from Survey division.

Despite this payment 150k disappeared into the air.... we are still waiting the



survey.

Unhappy of this unfair treatment we surrendered to the Malacanang office of the president. Presidential complaint center on july 19 /2022. filing the case. After our contact realized the many errors and ask appropriate action to DENR. Soon 5 Months after nothing has been done our file is transferred from service to service and we spend our time and our money traveling from Mindoro island to manila and calling without result. Every day we have to come back another day, another day we have to come back another week and so on and so fourth.....

In more than 2 years we got only that wrong survey that my granddaughter would be able to do better

An inexplicable bifurcation than 4 meters to avoid the overhanging house was materialized with a stick!!!

We have a survey carried out by INGR Castro, geodetic ingeneer with 100 benchmark noting encroachment

We have an appointment with Senator Tulfo and we will go back to presidential complaint center

:Enough is enough!

I would never give up you may have power but not the power to change the geography!

I only want an honest survey or aknowledgment of engineer Castro survey and justice!
