IMPLEMENTATION

In connection to the DAO 2017-08, states that the DENR aims to transform programs and projects into GEMs where household members create sustainable goods and services for the rehabilitation of degraded ecosystems, create viable community enterprises where households are the focal members and players in creating value-added environmental products and services, and accelerate the rehabilitation of degraded ecosystems and promote the protection of the environment through the creation of green jobs.

Hence, one of the targets to be implemented under Green Economy Model (GEM) is the Focus Group Discussion (FGD) that aims to improve the livelihood and enterprise development of the community. Whereas, the locals in the community will be able to raise their concerns regarding on how they will continue or create a sustainable livelihood that is suitable within their area and continuous conservation of our natural resources.

Said activity was conducted on November 09, 2022 in Barangay Poblacion 6, Coron, Palawan where it was participated by 35, individuals composed of Senior Citizen, Barangay Officials and volunteers from different sectors of the community. Some of the suggestions raised during the FGD was mainly on the rehabilitation of nursery in their coastal areas, handicraft making, souvenir shops, agri-tourism and development of ecotourism such as hiking and mountaineering in Mt. Dalara. During the activity, Barangay Captain Maria V. Cinco mentioned that in Poblacion 6 has a lot of resources especially in their upland areas. Also, there are two (2) watershed areas within their area of jurisdiction that supplies the water in six (6) Poblacion Barangays. Thus, the BLGU discourage such activities that may compromise and risk the vital resources.

All information gathered were sum-up and briefly discussed for a possible recommendation and creation of livelihood opportunities
