

**MEMORANDUM DATED 06 DECEMBER 2022** 

This is in compliance with the Memorandum dated December 06, 2022 of the Undersecretary for Legal, Administration, Human Resources and Legislative Affairs directing the Regional Executive Directors to submit the following informations covering the periods 2011 to 2022, segregated yearly:

- 1. Number of cases instituted by your respective offices and/or number of cases filed in courts and quasi-judicial agencies, and
- 2. Number of ENR cases resolved or disposed.

Due to the lack of data resources available and insufficiency of time required, the data gathered by this Office pertains only to cases initiated from CY 2012 up to present. However, the list is not complete as other files were missing. Below is the summary of the number of cases filed per CENROs.

The PENRO Palawan commenced the hiring of contractual lawyers only during the last quarter of 2017. However, the same was stopped during CY 2021 due to the consecutive issuance of Notice of Disallowances issued by the Commission on Audit. For more or less than four (4) years, the probable impact of hiring contractual lawyers in the CENR Officer and PENRO Palawan is that the contractual lawyers contributed to the number of cases initiated and resolved as they facilitated the preparation and filing of complaints and rendered assistance in the prosecution of ENR criminal cases. Further, the contractual lawyers also had an impact on the smooth day-to-day operations of the CENROs through the issuance of legal opinion and verbal legal advise when confronted with legal issues.

At present, the PENRO Palawan do not have any Contractual Lawyers. During March 2022, PENRO Palawan created the PENRO Legal Unit composed of Legal Researchers under the undersigned's control and supervision.
