I am submitting this report in compliance with your instruction to conduct an investigation on this application for Survey Authority.

SUBJECT LOT

The subject land of this investigation is Lot No. 510, PLS-798, located in Bgy. Rizal, Roxas, Palawan, with an area of 77,409.76 square meters.

CLAIMANT

The claimant is Edilberto A. Dagot, 53 years old, male and a resident of Barangay Rizal, Roxas, Palawan.

PROCEEDINGS/ACTIVITIES UNDERTAKEN

Upon receipt of your instruction, I immediately conducted the investigation. The following were undertaken:

- First gathered geographic reading and caused verification thereof by the Cartographer on the cadastral map over which the Surveys and Mapping Division (SMD) has overlaid the LC maps; by the Records Officer of the disposition status thereof, and prepared the LC certification based on the findings.
- 2. The joint affidavit executed in the support thereof by two disinterested persons, was validated on site as evidenced by the attached photographs apt for geo-tagging.

FINDINGS/RECOMMENDATION

After the conduct of the investigation, I found out the following:

- The subject area is within Agricultural lands (alienable or disposable). Attached for further evaluation by the PENR Officer and confirmation by the ARD for technical is a certification prepared to that effect following Annex B of DMC 2019-10.
- The subject area was converted into coconut plantation and several bearing fruit trees was also observed.
- 3. Occupied by parents of the applicant and their occupation is peaceful ever since.

I therefore recommend for the approval of the application for survey authority. Attached are geotagged photographs of the subject lot.


