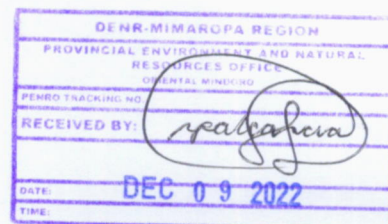

In compliance with the provisions of DENR Administrative Order No. 97-32 (DAO 97-32), an **Administrative Adjudication Proceeding** has been commenced relative to the above-cited subject. The corresponding **Summary Confiscation Hearing** was scheduled by the undersigned hearing officer on **08 November 2022** at DENR-CENRO Socorro, Barangay Pasi II, Socorro, Oriental Mindoro.¹

The apprehending officer in this proceeding is **PSSg Mark Anthony Priela** of Socorro Municipal Police Station (Socorro MPS) while the respondent involved is **Joel Pacis Maisug** *who remained at-large*. Hence, the narration below and recommendation of the hearing officer are based on material and relevant pieces of evidence gathered from the apprehending officer only.

ANTECEDENT FACTS

At around 3:30 in the afternoon of 06 October 2022, PSSg Priela received an information from a member of Barangay Intelligence Network (BIN) about an alleged stockpile of lumbers located along the road of Sitio Antipolo, Barangay Mabuhay I, Socorro. Such information was confirmed upon inspection of the area.²

PSSg Priela asked nearby residents to determine the owner/s of the lumbers. It was discovered that these belong to respondent Maisug, resident of Barangay Maria Concepcion, Socorro, who remained at large. A total of forty-four (44) pieces of lumber were apprehended and marked as "JM1" to "JM44".

Police blotter relative to this incident (**Blotter Entry No. 2022-10-1070**) was accordingly filed by PSSg Priela against respondent Maisug.³

On 13 October 2022, the said lumbers were scaled and turned-over to DENR-CENRO Socorro. An **Apprehension Receipt** was issued on the same date.⁴

The corresponding **Seizure Order** and **Seizure Receipt** were then issued by the undersigned to take official custody of the apprehended lumbers, with details to wit:⁵

As regards the whereabouts of respondent Maisug, it was discovered that he is *not* a resident of Barangay Maria Concepcion, Socorro per Certification issued by Punong Barangay Virgilio A. Baculo.⁶

ISSUE

Whether or not the santol lumbers shall be confiscated in favour of the government.

RECOMMENDATION

WHEREFORE, undersigned hearing officer, respectfully recommends the following:


The 44 pieces of santol lumbers without the corresponding cutting nor transport permit from DENR shall be confiscated in favour of the government and be disposed of in accordance with existing laws and procedures.

Section 77 of Presidential Decree No. 705, as amended, otherwise known as "Revised Forestry Code of the Philippines," provides that:

Any person who shall cut, gather, collect, removed timber or other forest products from any forest land, or timber from alienable or disposable public land, or from private land, without any authority, or possess timber or other forest products **without the legal documents** as required under existing forest laws and regulations, shall be punished with the penalties imposed under Articles 309 and 310 of the Revised Penal Code.⁷

Based on the records, *neither tree cutting permit nor transport permit was issued to respondent Maisug*.⁸ Section 77 of PD 705, as amended is clear that cutting, gathering, collecting, or removing timber from private or public land, without any authority, is illegal and subject to administrative confiscation.





DTPO: October 6, 2022 at about 4:00 PM at Sitio Antipolo, Brgy. Mabuhay I, Socorro, Oriental Mindoro.

FACTS OF THE CASE:

On the said DTPO information received from our BIN that there was an illegally sawn lumbers at the aforementioned barangay.

That prompted the operating elements of this station led by PSSg Mark Anthony Priela, Intel PNCO, together with the personnel of 2nd Platoon 1st (PMFC) Provincial Mobile Force Company proceeded at the said place and validated the information which resulted to the confiscation of forty four (44) pieces in different dimension (20pcs. of 2X3X6 feet long, 20pcs. of 2x3x8 feet long and 4pcs. of 2x3x10 feet long) of Lawaan sawn lumbers with an estimated volume of One Hundred Sixty board feet (160 bd/ft) and with a total street value of approximately Eleven Thousand Two Hundred pesos (Php 11,200.00). Based on thorough interview to possible witnesses near the said place of incident, the said lumbers were illegally sawn by the suspect.

Subsequently, confiscated lumbers were brought to this station for further documentation and will be turned over to CENRO at Brgy. Pasi 2, Socorro Or. Mindoro while a case for violation of PD 705 is being prepared by this station against the suspect.
