With the implementation of the LAWIN Forest and Biodiversity Protection System, respectfully submitted is the detailed report of the Busuanga Pasture Reserve Management Office (BPRMO) on the results of the Lawin monitoring and patrolling activities conducted in the Municipalities of Busuanga and Coron, Palawan within the BPR area for the 4th Quarter of 2022.

V. Findings and Result

Two (2) Patrol Teams were dispatched during the conduct of this activity within the Forest Conservation Area (FCA) of BPR situated in the Municipalities of Coron and Busuanga, Palawan. The target distance from October to December 2022 is 90 kilometers (km) based on the Lawin Patrol Plan for 4th Quarter of 2022. Based on the results, the BPRMO Patrol Teams were able to traverse an aggregate distance of 98.89 km or 109.87 % (Table 1).

*The accomplishment rate is computed based on the 30 kilometer target per CENRO/CA per month compared to the sum of the distance patrolled per CENRO/CA.

Table 2. Shows a total of 1,324 Forest Condition Counts (FCCs) recorded during the patrolling. Open-Uncultivated (OUC) appears to have the highest figure recorded for the 4th Quarter of 2022 with 503 counts or 38%, while Old Growth Forest has the least with 24 counts or 2%. The remaining forest conditions such as: Early Secondary Forest (ESF), Open-Cultivated (OC), and Advance Secondary Forest (ASF) with corresponding total figures of 488 (37%), 161 (12%), and 148 (12%), respectively. Based on the SMART analysis, the total FC

with the good condition has a total count of 660 or 50% which includes OGF, ASF and ESF. The OUC count appears to be significant, but this is due to teams traversing large grassland areas which is a natural feature of BPR while conducting the patrol.

With respect to the presence of natural regenerants, 724 FCCs or 54.68% of the total FCC were recorded with presence of natural regenerants while 600 FCCs or 45% with absence of natural regenerants. There were fourteen (14) or 1% recorded dense natural regenerants, while three hundred twenty-four (324) FCCs or 24% and three hundred eighty-six (386) or 29% are recorded as moderate and sparse natural regenerants, respectively (Table 3).

Table 4 shows the observed and recorded threats within the FCA of BPR. A total of twenty-three (23) counts of threats were observed and recorded during the implementation of Lawin Forest and Biodiversity Protection System for the 4th Quarter of 2022. Cutting of trees recorded the highest counts with sixteen (16) recorded occurrence or houses and other infrastructures with five (5) recorded counts and slash and burn farming (kaingin) with two (2) recorded counts.

As can be viewed from the map in Annex C, the threats observed/documented in the FCA during the 4th Quarter (October, November and December) 2022 were found in Barangays of Decalachao, Bintuan, and Guadalupe, Coron, and Brgy. Quezon, New Busuanga, San Rafael and Cheey, Busuanga, Palawan. The current threat index was computed as 0.34 threats per kilometer (T/Km) on October 2022, slightly decreased to 0.24 on November 2022 and continuously decreased to 0.12 this December 2022.

VI. Actions Taken by the BPRMO for the observed threats

Pertaining to the twenty-three (23) observed/recorded threats for the 4th Quarter of 2022, the BPRMO conducted the following actions for the month of October, November and December respectively (Pleased see the table 5 and 6)

I. Remarks and Recommendations

1. Frequency of the visibility of patrolling and LAWIN monitoring within the Forest Conservation Area of BPR is being intensified to include weekends, if necessary, in order to prevent and immediately address any possible threats within the forested areas of BPR;

- To send communication letter address to the Barangay for the conduct of followthrough action of the BPRMO personnel with a record of threats observed in every conduct of LAWIN patrolling and monitoring to inform and assists them if it requires urgent action;
- 3. Observed unlawful activities on the ground are being thoroughly investigated and documented and filing of appropriate criminal complaints against the offenders pursuant to Presidential Decree No. 705 of 1975 as amended and other environmental laws, if so warrant;
- 4. Conduct of seminar/IEC to every barangay recorded with a high incidence of unlawful activities within the area covered by the BPR to provide awareness and educate the community on the importance of maintaining ecological and environmental balance in the locality and the benefits that could be derived from the forest and climate change mitigation; and
- Conduct of rehabilitation activities such as tree planting, enrichment planting and assisted natural regeneration to maintain and accelerate the recovery of forest cover.



Protection efforts are effective, when records of forest condition, regeneration and indicator species show an upward trend towards more observations more and denser regeneration, particularly in degraded forest areas. Increasing trends in indicator species suggest that the improved forest condition is providing a better habitat for forest dependent species. All trends presented are put in relation to the patrol effort to provide comparability. Forest cover data were derived from 2003 and 2010 NAMRIA land cover maps.


Trends of Observations per Patrol Kilometer in the Forest Conservation Area

Trend in Indicator Species




An increasing trend in indicator species in the forest conservation area means effective forest protection; a decreasing trend means the opposite.






Location of observed threats









Locations of actions taken to address threats
