



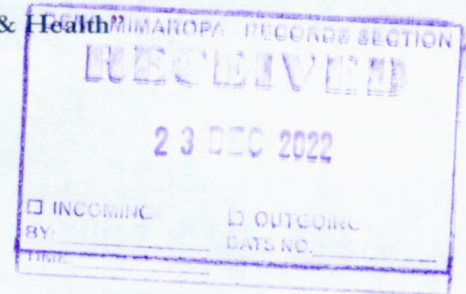


To transfer, follow-up, comply with any requirements, and execute any document with any government or private office in pursuance of the aforementioned;




