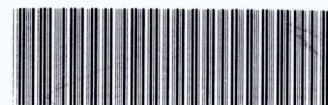
This refers to the memorandum on the submission of list of community watersheds declared by the DENR Secretary or with co-management agreement with LGU.

Item	Agreements
On the identification, effective management and protection of watersheds that supplies the water requirements of water districts.	FMB to attach the list of Watersheds that supports the water requirement of water districts based on the overlaying of the watershed boundaries and geographic locations of the facilities of PAWD and LWUA. PAWD and LWUA to provide FMB geographic locations of facilities for delineation.
On the provision of list of community watershed to PAWD and LWUA	FMB to request all Regional Offices to submit all community watershed declared by the DENR Secretary or with co-management agreement with LGU for information and ready reference of PAWD and LWUA.
On the request of PAWD and LWUA for a copy of the guidelines on declaration of community watersheds for their reference	FMB to provide PAWD, LWUA and DILG guidelines on the declaration of community watersheds.
On the additional comments of FMB, PAWD, LWUA and DILG on the draft MOA.	FMB to provide the copy of revised draft MOA via Google Docs to PAWD, LWUA and DILG for final comments suggestions.
On the finalization of the MOA.	FMB to conduct final meeting among DENR, PAWD, LWUA and DILG once all comments suggestions have been incorporated.
