Respectfully forwarded is the memorandum of CENRO Taytay, Palawan dated November 22, 2022 relative the above subject.

Per report, the apprehension was made on November 10, 2022 at around 6:30 P.M. by the personnel of Protected Area Management Office of Malampaya Sound Protected Landscape and Seascape (MSPLS) during the conducted monitoring of mangroves within the vicinity of Barangay Liminangcong, Taytay, Palawan.

The team intercepted and apprehended one (1) motorized boat loaded of 20 sacks of charcoal (Bakawan) operated by Joelito Estrella together with his three (3) companions (minors) while the owner of charcoal was identified as Oscar Nilo in gross violation of Section 18 (Section 20 of R.A. 7586) of R.A. 11038 (ENIPAS Act). Further, the said motorized boat and charcoal were brought to the PAMO of MSPLS, Barangay Old Guinlo, Taytay, Palawan for safekeeping.

CENRO Taytay is now conducting administrative proceeding and submit report in accordance with DAO 1997-32.

Investigation revealed that certain Oscar Nilo was the owner of the boat and charcoal.

Respectfully forwarded is the memorandum dated November 15, 2022 of Forest Ranger Francis Abe G. Bose et. al. concerning the above subject.

Please be informed that on November 10, 2022, this Office apprehended one (1) motorized boat loaded of twenty (20) sacks of charcoal (bakawan) in possession of Mr. Joelito Estrella with his three (3) companions of minor age at Barangay Liminangcong, Taytay, Palawan. Based on the investigation, a certain Mr. Oscar Nilo of Barangay Liminangcong was the owner of the boat and charcoal and they are purposely hired by Mr. Nilo for the delivery. Likewise, on the interview conducted, Mr. Nilo's wife admitted that they are the owner of boat and charcoal.

This Office recommends to continuously conduct the patrol and monitoring and increase awareness through Information, Education and Communication (IEC) campaign to the BLGUs and other partners within MSPLS.

This pertains on the apprehended one (1) motorized boat loaded of 20 sacks of charcoal (bakawan) in the above mentioned date and place.

Please be informed that on November 10, 2022 at around 6:30 in the evening, we the undersigned together with the Office Support Staff – Ricben R. Armenia, Roniel C. Solana, Richard M. Valones and Belly C. Barcoma apprehended one (1) motorized boat loaded of 20 sacks of charcoal (bakawan) at Barangay Liminangcong, Taytay, Palawan operated by Mr. Joelito Estrella together with his three (3) companions (minors). Based on the information gathered from Mr. Estrella, a certain Mr. Oscar Nilo, residents of the said barangay was the owner of the boat and charcoal, they just hired of Mr. Nilo to pick up the charcoal from Sitio Tulduan, Barangay Liminangcong and to deliver the charcoal at barangay proper, but Mr. Nilo did not showed just only his wife admitting they are the owner of the boat and 20 sacks of charcoal. We explained that we apprehended their boat and charcoal for violation of Section 20 of R.A. 11038 (ENIPAS Act).

Be informed further that the motorized boat and 20 sacks of charcoal (bakawan) was brought to the Protected Area Management Office (PAMO) at Barangay Old Guinlo, Taytay, Palawan for safekeeping purposes.
