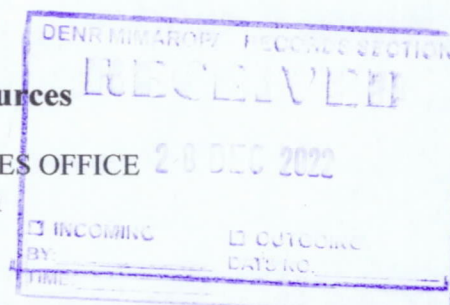

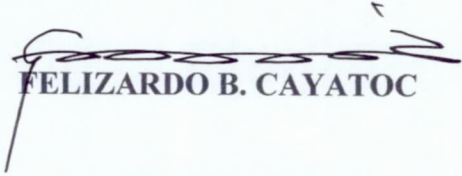
Respectfully forwarded is the memorandum of CENRO Puerto Princesa, Palawan dated November 7, 2022 relative the above subject.

Per memorandum, the apprehension was made on August 25, 2022 at around 7:40 P.M. by the personnel of CENRO Puerto Princesa and inspected the suspicious vehicle in reference to the information relayed by the informant. The team apprehended the One (1) unit Fuso Truck with plate number RJK 762 loaded with forty-three (43) sacks of wood charcoal and two (2) set of Ipil Door Jamb without the required permit in violation of Section 77 of PD 705, as amended. The estimated fair market value of vehicle is Php200,000.00 while the charcoal is Php8,600.00 and the door jamb is Php16,000.00. The driver of the vehicle identified as Dionny F. Realino and requested to bring the vehicle to CENRO Puerto Princesa for safekeeping under the custody of Forester I Arjay T. Gregas. The owner of the conveyance is Rodel S. Duhig, admitted during the hearing that he has a trucking business transporting agricultural products and not aware of the transportation of charcoal and the door jamb. Other involved persons were Ralf Pacificador, Nelgie Tampicao and Mark Aveth Gargallano.

Notice of hearing was released on August 31, 2022 and sent to both parties and the hearing was conducted on September 2, 2022 in relation to Section 7 of DAO 1997-32. Further, on December 6, 2022, the PENRO Appraisal Team submitted the report to PENRO for the temporary release of the conveyance to its rightful owner upon payment of the recommended cash bond of Php469,998.88 and submission of other pertinent documents in relation to Section 9 (Temporary Release of Conveyance) of DENR Administrative Order No. 1997-32.

We concur with CENRO recommendation for the issuance of confiscation order of the apprehended 43 sacks of wood charcoal and 2 set of Ipil Door Jamb.

Respectfully submitted is the summary of Administrative Adjudication relative to the above subject.

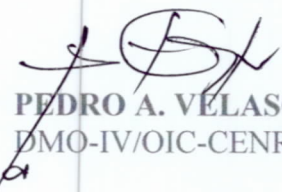
Please be informed that this Office conducted administrative hearing last September 02, 2022, pursuant to Department Administrative Order (DAO) 97-32. The hearing disclosed that one (1) Fuso Truck (with Plate No. RJK762) is loaded with Forty-Three (43) sacks of charcoal and 2 sets of Ipil door jamb without legal documents. The Hearing Officer recommended for the confiscation of charcoal and door jamb and temporary release of conveyance used to its rightful owner due to failure to establish the participation of the conveyance owner in the illegal transport of forest products.

Upon review and evaluation of the report submitted including its attachments, the undersigned concur with the recommendation of the Hearing Officer subject for review at the Regional Office.

Respectfully submitted is the summary of Administrative Adjudication of FUSO Truck with Plate Number RJK762 loaded with forty-three (43) sacks of charcoal and two set door Jamb made of Ipil lumber.

I. FACTS OF THE CASE

On or about 7:40 in the evening on August 25, 2022, at Brgy. Sta. Monica, Puerto Princesa City one (1) unit truck owned by Rodel Duhig bearing plate No. RJK762 was apprehended. The truck was loaded with 43 sacks of charcoal and 2 sets of door jambs made of Ipil lumbers. Upon verification and investigation of the apprehending officer, FTI Rommel Adato, the driver and his helpers were not able to show any valid permits for its load, hence, confiscation was declared by the apprehending officer, and the conveyance and its load were brought to CENR Office for custody.

During the administrative hearing the driver, Mr. Diony Realino admitted that the charcoal and its load has no permit. It was from Ladayon, Quezon, Palawan which was loaded by some person waiting along the highway. According to him, they were not able to get the name of the owner of the forest products but they had an arrangement with that person that when they arrive at PPC someone will contact them using a cellular phone to pick up the charcoal and the door jamb. Such statements of Mr. Realino were corroborated by its helpers.

The owner of the vehicle Mr. Rudil Duhig was also present during the hearing. He mentioned that he was engaged in a trucking business transporting agricultural products. He was not among those people present during the apprehension of his truck and he was not aware of the transportation of charcoal and door jamb using his conveyance.

II. NOTICE OF HEARING

The notice of hearing was released on August 31, 2022 and the hearing was conducted on September 02, 2022.

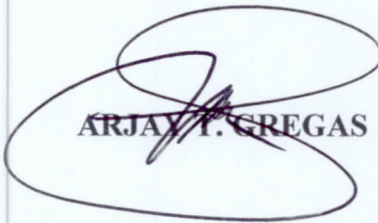


III. EVALUATION

Based on the facts, it is well settled that the respondents do not have legal documents in transporting the forty-three (43) sacks of charcoal and two (2) sets of Ipil door jamb. There was a clear violation of the PD 705 Sec. 77 which stated that: *"Any person who shall cut, gather, collect, removed timber or other forest products from any forest land, or timber from alienable or disposable public land, or from private land, without any authority, or possess timber or other forest products without the legal documents as required under existing forest laws and regulations, shall be punished with the penalties imposed under Articles 309 and 310 of the Revised Penal Code..."* However, it is also settled that the owner has no knowledge about the illegal activities of his driver.

IV. RECOMMENDATION

It is recommended that the 43 sacks of charcoal and 2 sets of door jamb be confiscated in favor of the government and the conveyance be temporarily released to its rightful owner subject for review at the Regional Office.
