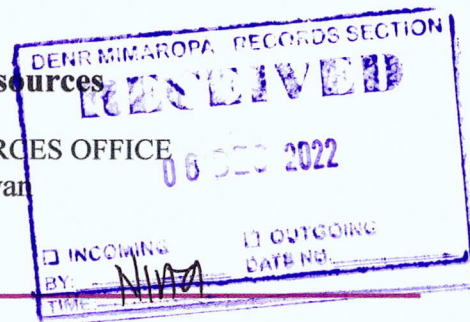

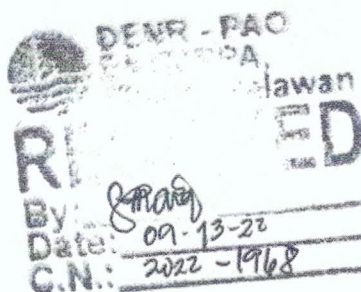

Respectfully submitting is the Memorandum Report dated September 15, 2022 of the Protected Area Superintendent Mildred A. Suza relative to the above subject with enclosures.

Please be informed that the Protected Area Superintendent (PASu) of El Nido-Taytay Managed Resource Protected Area – Protected Area Management Office (ENTMRPA-PAMO) conducted an administrative hearing last August 30, 2022. The hearing disclosed that Mr. Christopher Aconin along with the six (6) crews committed a violation in relation to Section 20 (e) and (g) of the Republic Act 7586 as amended by Section 18 of Republic Act 11038. Further, the owner of the motorbanca submitted his Affidavit of Undertaking with Prayer to Release and Temporary Custody of the said fishing vessel.

Upon review and evaluation of the report submitted including its attachment, the undersigned concur with the recommendation of the Hearing Officer subject for review at the Regional Office.
