Respectfully forwarded is the memorandum of CENRO Taytay, Palawan dated October 25, 2022 relative the above subject.

Per memorandum, the recovery/apprehension was made on April 7, 2022 at around 9:45 P.M. by the enforcement personnel of CENRO Taytay, Barangay Officials and ENTMRPA Park Rangers/Forest Protection Officers while doing patrolling activities and subsequently found the left-overs piled of lumbers in the area after detection that there is operation to be conducted by the enforcement team at Sitio Swamp, Barangay Aberawan, El Nido, Palawan. No one seen within the vicinity during the recovery. Hence, the team concluded that the lumbers were abandoned.


The Team apprehended the twelve (12) pieces (158 board feet) lumbers of Apitong species of different dimensions with estimated fair market value of Php9,480.00. The subject abandoned lumbers were brought and deposited at Forest Products Monitoring Station II at Barangay Bagong Bayan, El Nido, Palawan for proper safekeeping purposes under the custody of Administrative Aide VI/CENRO Property Custodian Norie D. Pineda.

Notices to the public dated May 4, 2022, May 11, 2022 and May 18, 2022 were posted to different public places pursuant to DAO 1997-32. In spite of the three (3) consecutive notices posted on different conspicuous places, no claimant appeared before the CENR Office. Hence, absence of the owner/claimant to appear/claim shall be deemed a waiver of their rights to the apprehended item in favor of the government. Further, the notice of hearing dated August 18, 2022 was sent to all concerned parties and finally on August 26, 2022 the administrative hearing was conducted at DENR CENRO Taytay, Palawan.


We concur with CENRO recommendation for the issuance of confiscation order of the apprehended forest product in favor of the government.

This report is respectfully submitted pursuant to Department (DENR) Administrative Order 97-32 dated October 10, 1997.

**WHAT**

This is the final report on the administrative adjudication of the twelve (12) pieces of lumber of Apitong species equivalent to one hundred fifty-eight (158) board feet.

**WHEN**

The interception/recovery took place last April 7, 2022 and the corresponding report was submitted and received in the Office on April 11, 2022 (Annex A to A<sub>1</sub>) plus the geo-tagged pictures (Annex B), and Apprehension Receipt (Annex C to C<sub>2</sub>).

**WHERE**

The forest products were recovered in Sitio Swamp, Barangay Aberawan, El Nido, Palawan and brought to Forest Product Monitoring Station (FPMS) II at Bagong Bayan, El Nido, Palawan.

**WHO**

The so-called Apprehension Receipts bear no name of probable culprits. The operating enforcers were Forest Ranger John Vincent G. Sanchez along with the Forest Protection Officers of FPMS I, ENTMRPA Forest Protection Officers and Barangay Officials of Aberawan, El Nido, Palawan.

**WHY**

The subject items of forest products were taken and seized for failure by anybody to claim with valid documents despite invitation in public notice posted in three consecutive weeks.

**HOW**

The Chief of Enforcement and Monitoring Section instructed FR Sanchez to provide assistance to the FPOs of ENTMRPA assigned at FPMS II, Bagong Bayan, El Nido, Palawan with their apprehension. The team proceeded to the area along with the Barangay Officials of Aberawan, El Nido, Palawan. Accordingly, the lumber were left-overs and was not retrieved by



the perpetrators because allegedly, they were informed about the operation. The items hauled to Forest Product Monitoring Station at Bagong Bayan, El Nido for safekeeping.

### Adjudication procedure

Seizure Receipt (D) and Seizure Order (Annex E to E<sub>2</sub>) and were facilitated on May 4, 2022 in order to acquire jurisdiction over the intercepted items. The seized items have an estimated value of nine thousand four hundred eighty (9,480.00) pesos. Public notices (Pabatid sa Publiko) were posted consecutively every week on May 4, 11, and 18, 2022 (Annexes F to F<sub>2</sub>). The Certification of the Records Officer dated May 25, 2022 was then issued upon completion of the posting of Pabatid to the Public (Annex G).

In the absence of claimant, the undersigned opted to adjudicate the issue on the basis of the report submitted. This Office sent invitation to Forest Ranger John Vincent G. Sanchez et. al, and Punong Barangay Rodante V. Reynoso of Barangay Aberawan, El Nido, Palawan to a hearing on 26<sup>th</sup> day of August, 2022 at 4:00 in the afternoon (Annex H to H<sub>1</sub>).

The examination pushed through as evidenced by the Attendance Sheet (Annex I). Preliminaries such as attendance check and the IEC presentation was set aside since all of the attendees were personnel from this Office.

On the examination, *Hearing Officer* directly asked on how did the information about the lumber came to the knowledge of the Apprehending Officer and the location of the lumber. FR Sanchez introduced himself being the Team Leader of FPMS III; that around 9 in the evening of April 7, 2022, FPOs of FPMS II requested for an assistance since they had an apprehension; that they proceeded to the area and the Barangay Officials helped the team hauled the lumber. FR Sanchez also mentioned that the lumber was brought to the FPMS II at Bagong Bayan. *HO to FR Sanchez* inquired if follow up investigation was conducted by the team. *FR Sanchez* replied to have an investigation on the night when the incident took place and relayed that accordingly, the perpetrator didn't retrieved the lumber and they cannot identify the perpetrator hence declared the lumber as abandoned. Without further clarifications, *HO* then adjourned the hearing.

Transcript of the minutes is Annex J and J<sub>1</sub>.

### Conclusion and recommendation


The items listed down in the Seizure Order and Seizure Receipt are deemed abandoned thus hereby recommended for the issuance of Order of Forfeiture.

Please be informed that the undersigned together with Forest Protection Officers Reynold N. Ortega, Gilbert R. Angeles, Rommel R. Esponja and Science Research Specialist – I Francis Jade R. Cometa responded to the call for assistance of Forest Product Monitoring Station – II, Bgy. Bagong Bayan, El Nido, Palawan on April 07, 2022.

The team received instruction from the Chief of Enforcement and Monitoring Section at around 09:00 P.M to respond to the mentioned Barangay to assist Forest Protection Officers assigned at FPMS-II, Bgy. Bagong-bayan, El Nido, Palawan with their apprehension. Upon arriving at Sitio Swamp, Barangay Aberawan, El Nido, Palawan, we immediately conducted investigation along with the Barangay Officials of Barangay Aberawan, El Nido, Palawan. Accordingly, the apprehended lumbers were only left-overs and was not retrieved by the perpetrators because allegedly, they were informed by their look-out about the operation. A total of twelve (12) pieces of Apitong (*Dipterocarpus grandifloras*) lumbers with a total volume of One Hundred Fifty Eight (158) board feet were apprehended and was brought to Forest Product Monitoring Station – II located at Barangay Bagong Bayan, El Nido, Palawan for safekeeping.

The undersigned recommends conducting follow-up operations within the area because some locals stated that there are chainsaw operations being conducted almost everyday within the same area.

Attached are the geotagged photos were taken during the said activity and the tally sheet of the apprehended lumbers..
