Respectfully forwarded is the memorandum of CENRO Taytay, Palawan dated November 9, 2022 relative the above subject.

Per memorandum, the recovery/apprehension was made on August 3, 2022 at around 10:00 P.M. by the enforcement personnel of CENRO Taytay and ENTMRPA Park Rangers/Forest Protection Officers while doing patrolling activities and subsequently found the piled of lumbers in the area at Sitio Bagong Silang, Barangay Bagong Bayan, El Nido, Palawan. No one seen within the vicinity during the recovery. Hence, the team concluded that the lumbers were abandoned.

The Team apprehended the twenty-one (21) pieces (104 board feet) lumbers of Maladuhat and Malamangga species of different dimensions with estimated fair market value of Php6,240.00. The subject abandoned lumbers were brought and deposited at Forest Products Monitoring Station II at Barangay Bagong Bayan, El Nido, Palawan for proper safekeeping purposes under the custody of Administrative Aide VI/CENRO Property Custodian Norie D. Pineda.

Notices to the public dated August 16, 2022, August 23, 2022 and August 30, 2022 were posted to different public places pursuant to DAO 1997-32. In spite of the three (3) consecutive notices posted on different conspicuous places, no claimant appeared before the CENR Office. Hence, absence of the owner/claimant to appear/claim shall be deemed a waiver of their rights to the apprehended item in favor of the government. Further, the notice of hearing dated October 4, 2022 was sent to all concerned parties and finally on October 14, 2022 the administrative hearing was conducted at DENR CENRO Taytay, Palawan.

We concur with CENRO recommendation for the issuance of confiscation order of the apprehended forest product in favor of the government.

This report is respectfully submitted pursuant to Department (DENR) Administrative Order 97-32 dated October 10, 1997.

WHAT

This is the final report on the administrative adjudication of the twenty-one (21) pieces of lumber of Maladuhat and Malamanga species equivalent to one hundred four (104) board feet.

WHEN

The interception/recovery took place last August 3, 2022 and the corresponding report was submitted and received in the Office on August 8, 2022 (Annex A to A₁) plus the geo-tagged pictures (Annex B), and Apprehension Receipt (Annex C to C₂).

WHERE

The forest products were recovered in Sitio Bagong Silang, Barangay Bagong Bayan, El Nido, Palawan and brought to Forest Product Monitoring Station II at Bagong Bayan, El Nido, Palawan.

WHO

The so-called Apprehension Receipts bear no name of probable culprits. The operating enforcers were Forest Technician II Bienvenido F. Veguilla III as Team Leader along with Forest Ranger Herson Y. Caliao and ENTMRPA Forest Protection Officers.

WHY

The subject items of forest products were taken and seized for failure by anybody to claim with valid documents despite invitation in public notice posted in three consecutive weeks.

HOW

The team received an information from a concern citizen regarding the pile of lumber more or less 20 meters from the National Highway of So. Bagong Silang, Barangay Bagong Bayan, El Nido, Palawan. They proceeded to the area and found the lumber. Having no claimant, they seized and declared it as abandoned. The lumber was then brought to Forest Product Monitoring Station at Bagong Bayan, El Nido for safekeeping purposes.

ADJUDICATION PROCEDURE

Seizure Receipt (D) and Seizure Order (Annex E to E₂) and were facilitated on August 16, 2022 in order to acquire jurisdiction over the intercepted items. The seized items have an estimated value of six thousand two hundred forty (6,240.00) pesos. Public notices (Pabatid sa Publiko) were posted consecutively every week on August 16, 23 and 30, 2022 (Annexes F to F₂). The Certification of the Records Officer dated September 6, 2022 was then issued upon completion of the posting of Pabatid to the Public (Annex G).

In the absence of claimant, the undersigned opted to adjudicate the issue on the basis of the report submitted. This Office sent invitation to Forest Technician II Bienvenido F. Veguilla III, Forest Ranger Herson Y. Caliao et. al, and Punong Barangay Ronilo O. Delos Santos of Barangay Bagong Bayan, El Nido, Palawan to a hearing on 14th day of October, 2022 at 3:30 in the afternoon (Annex H to H₁).

The examination pushed through as evidenced by the Attendance Sheet (Annex I). Preliminaries such as attendance check and the IEC presentation was set aside since all of the attendees were personnel from this Office.

On the examination, *Hearing Officer* asked the *Apprehending Officer* on the distance of the confiscated lumber to the community. *FT II Veguilla* introduced himself and replied that the information came from the concern citizen; that it is more or less 20 meters away from the highway with no few houses on the area. *HO* then asked if follow up investigation was conducted by the team. *FT II Veguilla* answered “yes” but there’s no identified claimant of the lumber. *HO* turned to *FR Caliao* asking for any additional information. *FR Caliao* answered “none”. *HO* now declared the lumber as abandoned and without further clarifications, *HO* then adjourned the hearing.

CONCLUSION AND RECOMMENDATION


The items listed down in the Seizure Order and Seizure Receipt are deemed abandoned thus hereby recommended for the issuance of Order of Forfeiture.

This is the report of the apprehended 21 pieces of abandoned assorted lumber with different dimension and aggregate volume of 104 board feet.

WHEN

The apprehension was done on August 03, 2022 at around 10:00 o'clock in the evening and the corresponding report was submitted and received in the Office on August 08, 2022 along with the geo-tagged photos, Tally Sheet and Apprehension Receipt.

WHERE

The apprehension took place at Sitio Bagong Silang, Barangay Bagong Bayan, El Nido, Palawan and the said undocumented forest products was brought by the undersigned to the Forest Product Monitoring Station FPMS-II, Barangay Bagong Bayan, El Nido, Palawan for safekeeping.

The said forest product was taken and seized in violation to Section 77 of Presidential Decree 705 as amended otherwise known as Revised Forestry Code of the Philippines as stated as "Any person who shall cut, gather, collect, or remove timber or other forest product from any forest land, or timber from alienable or disposable public lands, or from private lands, without any authority, OR POSSESS TIMBER OR OTHER FOREST PRODUCTS WITHOUT THE LEGAL DOCUMENTS AS REQUIRED UNDER EXISTING FOREST LAWS AND REGULATIONS, SHALL BE PUNISHED WITH THE PENALTIES IMPOSED shall be guilty of qualified theft as defined and punished under Article 309 and 310 of the Revised Penal Code.

HOW

The undersigned along with ENTMRPA Forest Protection Officer assigned at FPMS-II, Bagong Bayan Station received information from concern citizen that there's a pile of lumber more or less 20 meters the distance along the National Highway of Sitio Bagong Silang, Barangay Bagong Bayan, El Nido, Palawan. The Team engaged to the said area and conducted searched to the surrounding and then we found twenty one (21) pieces of assorted lumber with different dimension and aggregate volume of 104 board feet, the team decided to seize the said illegally cut lumber and declared as abandoned.

The said abandoned lumber was brought to the Forest Product Monitoring Station (FPMS-II) Barangay Bagong Bayan, El Nido, Palawan for safekeeping. Here the stated dimension below;


