Respectfully forwarded is the memorandum of CENRO Taytay, Palawan dated November 3, 2022 relative the above subject.

Per memorandum, the recovery/apprehension was made on March 10, 2022 at around 1:32 A.M. by the enforcement personnel of CENRO Taytay and ENTMRPA Park Rangers/Forest Protection Officers while doing patrolling activities and found the piled of lumbers in the area of Sitio Bagong Sikat, Barangay Bagong Bayan, El Nido, Palawan. No one seen within the vicinity during the recovery. Hence, the team concluded that the lumbers were abandoned.

The Team apprehended the sixteen (16) pieces (140 board feet) lumbers of Apitong species of different dimensions with estimated fair market value of Php8,400.00. The subject abandoned lumbers were brought and deposited at Forest Products Monitoring Station II at Barangay Bagong Bayan, El Nido, Palawan for proper safekeeping purposes under the custody of Administrative Aide VI/CENRO Property Custodian Norie D. Pineda.

Notices to the public dated March 16, 2022, March 23, 2022 and March 30, 2022 were posted to different public places pursuant to DAO 1997-32. In spite of the three (3) consecutive notices posted on different conspicuous places, no claimant appeared before the CENR Office. Hence, absence of the owner/claimant to appear/claim shall be deemed a waiver of their rights to the apprehended item in favor of the government. Further, the notice of hearing dated August 18, 2022 was sent to all concerned parties and finally on August 26, 2022 the administrative hearing was conducted at DENR CENRO Taytay, Palawan.

We concur with CENRO recommendation for the issuance of confiscation order of the apprehended forest product in favor of the government.

This report is respectfully submitted pursuant to Department (DENR) Administrative Order 97-32 dated October 10, 1997.

WHAT

This is the final report on the administrative adjudication of the sixteen (16) pieces of lumber of Apitong species equivalent to one hundred forty (140) board feet.

WHEN

The interception/recovery took place last March 10, 2022 and the corresponding report was submitted and received in the Office on March 14, 2022 (Annex A to A₁) plus the geo-tagged pictures (Annex B), and Apprehension Receipt (Annex C to C₂).

WHERE

The forest products were recovered in Sitio Bagong Sikat, Barangay Bagong Bayan, El Nido, Palawan and brought to Forest Product Monitoring Station (FPMS) II at Bagong Bayan, El Nido, Palawan.

WHO

The so-called Apprehension Receipts bear no name of probable culprits. The operating enforcers were personnel from the Forest Product Monitoring Station (FPMS II) composed of then Forest Ranger Gerald J. Namoc as Team Leader along with Forest Technician II Bienvenido F. Veguilla III and ENTMRPA Park Rangers.

WHY

The subject items of forest products were taken and seized for failure by anybody to claim with valid documents despite invitation in public notice posted in three consecutive weeks.

HOW

Forest Protection Officer Janseen Del Rosario conducted surveillance and monitoring at the aforementioned barangay. He found out illegally cut lumber covered with twigs and leaves near the creek. The team then proceeded to the area, searched and found undocumented forest products. The items were hauled to Forest Product Monitoring Station at Bagong Bayan, El Nido for safekeeping using the hired topdown.

ADJUDICATION PROCEDURE

Seizure Receipt (D) and Seizure Order (Annex E to E₂) and were facilitated on March 16, 2022 in order to acquire jurisdiction over the intercepted items. The seized items have an estimated value of eight thousand four hundred (8,400.00) pesos. Public notices (Pabatid sa Publiko) were posted consecutively every week on March 16, 23 and 30, 2022 (Annexes F to F₂). The Certification of the Records Officer dated April 6, 2022 was then issued upon completion of the posting of Pabatid to the Public (Annex G).

In the absence of claimant, the undersigned opted to adjudicate the issue on the basis of the report submitted. This Office sent invitation to Forest Technician I Gerald J. Namoc, Forest Technician II Bienvenido F. Veguilla III et. al, and Punong Barangay Ronilo O. Delos Santos of Barangay Bagong Bayan, El Nido, Palawan to a hearing on 26th day of August, 2022 at 2:30 in the afternoon (Annex H to H₁).

The examination pushed through as evidenced by the Attendance Sheet (Annex I). Preliminaries such as attendance check and the IEC presentation was set aside since all of the attendees were personnel from this Office.

On the examination, *Hearing Officer* directly asked on how did the information about the lumber came to the knowledge of the Apprehending Officer. *FT I Namoc* answered that the information came from a concern citizen; that the topdown loaded with the Apitong lumber passed through the station and was chased by the FPO; and that the topdown went directly to the said barangay and left the lumber there. *HO* asked the identity of the topdown and the possible owner of the lumber. *FT I Namoc* answered that according to the FPO, the owner of the topdown is one Kevin Galan but unfortunately declined that he owned the vehicle. *HO* asked for the recommendation of the Apprehending Officer. *FT I Namoc* replied to write letter addressed to Galan to clarify his possible involvement on the case. Without further clarifications, *HO* then adjourned the hearing.

Transcript of the minutes is Annex J to J₁.

CONCLUSION

This Office sent a letter to Mr. Jevin Galan to clarify the allegation against his alleged involvement on the latter (Annex K).

RECOMMENDATION

Upon evaluation of the matter, the undersigned recommended that Mr. Kevin Galan be put on the watch list of this Office. Meanwhile, the items listed down in the Seizure Order and Seizure Receipt are deemed abandoned thus hereby recommended for the issuance of Order of Forfeiture.

This report is respectfully submitted pursuant to the memorandum of the Undersecretary for Field Operations, Enforcement and Muslim Affairs dated July 01, 2020.

WHAT

This is the report of the apprehended sixteen (16) pieces of abandoned Apitong lumber with different sizes with corresponding total volume of 140 board feet.

WHEN

The apprehension was done on March 10, 2022 at around 1:32 o'clock (dawn) and corresponding report was submitted and received in the Office on March 14, 2022 along with the geo-tagged photos and Apprehension Receipt with Tally sheet.

WHERE

The apprehension took place at Sitio Bagong Sikat, of Barangay Bagong Bayan, El Nido, Palawan and the said allegedly illegal cut lumber was brought by the undersigned to the nearest station which is Forest Product Monitoring Station FPMS-2 Bagong Bayan, El Nido, Palawan for safekeeping and further investigation.

WHO

There is no probable offender to the said area, and the enforcement personnel apprehended of (16) pieces of abandoned Apitong lumber with different sizes are Forest Technician-I Gerald J. Namoc, Forest Technician-II Bienvenido F. Veguilla III together with Forest Protection Officers Janseen Del Rosario, Romnick Juan, Danilo Moreno, and newly hired FPOs from CENRO Taytay office.

WHY

The said forest product was taken and seized in violation to **Section 77 of Presidential Decree 705 as amended** otherwise known as Revised Forestry Code of the Philippines as stated as "Any person who shall cut, gather, collect, or remove timber or other forest product from any forest land, or timber from alienable or disposable public lands, or from private lands, without any authority, OR POSSESS TIMBER OR OTHER FOREST PRODUCTS WITHOUT THE LEGAL DOCUMENTS AS REQUIRED UNDER EXISTING FOREST LAWS AND REGULATIONS, SHALL BE PUNISHED WITH THE PENALTIES IMPOSED shall be guilty of qualified theft as defined and punished under Article 309 and 310 of the Revised Penal Code);



HOW

Forest Protection Officer Janseen Del Rosario conducted surveillance and monitoring at Sitio Bagong Sikat of Barangay Bagong Bayan, El Nido, Palawan. He found-out illegally cut lumber covered with twigs and leaves near at the creek and after a while, He going back to station and alarming to us on duty. That the undersigned together with other Forest Protection Officers from ENTMRPA and newly hired FPOs from CENRO Taytay office proceeded to the said area and searched the surrounding, we found of sixteen (16) pieces of apitong lumber with different sizes and corresponding total volume of 140 board feet, the team decided to seized the item also allegedly illegal cut lumber and proclaimed as abandoned.

The undocumented forest product was brought thru hauling using hired top down and brought to the nearest station which is FPMS-2 station of Barangay Bagong Bayan, El Nido, Palawan for safekeeping and further investigation.

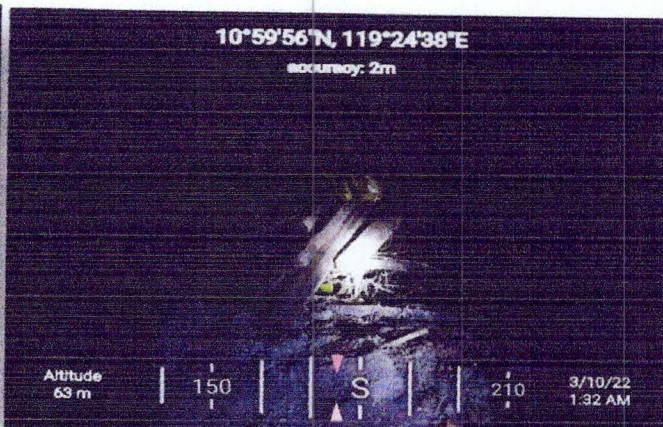


Figure 1. Pictures shown above are the origin which is the lumber found covered by twigs and leaves near at the creek at Sitio Bagong Sikat of Barangay Bagong Bayan, El Nido, Palawan.

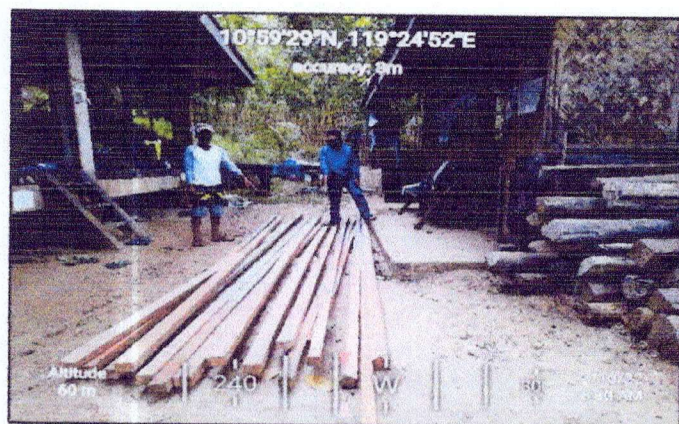


Figure 2. Pictures shown above are the lumber brought from the site to FPMS-II Bagong Bayan Station for safekeeping and further investigation.
