NOW THEREFORE, this resolution is being sponsored by Nazaria F. Fopalan, Federation President, Looc, Romblon and seconded by the majority.


RESOLVED, to authorize Mrs. Evelyn C. Gonzalez to apply for titling on the above cited request through DENR technical assistance and consideration.




