Attached is the transcript of the Minutes of the Administrative Hearing undertaken on the case *Department of Environment and Natural Resources*—versus- Alonzo Nava Minesterio for violation of Section 77 formerly Section 68 Presidential Decree 705 as amended by Executive Order 277 series of 1987 and Section 7 of RA 9175. Please be informed that Administrative Hearing was conducted last November 7, 2022 in accordance with Item 2, Section 7 of DAO 97-32 which was attended by respondent, with the following observations:

- 1. Based on the spot report of the Municipal Police of Gloria, apprehension was made by Pat. Kim Lorenz Fiedalan around 2:10 PM in So. Bulihan, Barangay San Antonio, Oriental Mindoro while conducting anti-illegal logging operation. One person were arrested and identified as Alonzo Nava Minesterio.
- 2. Alonzo Nava Minesterio were caught in the act of sawing lumbers of Antipolo trees.
- 3. Upon inspection, the apprehended persons failed to present the permit to cut and a chainsaw registration on that day resulting to their arrest. Six (06) pieces of Antipolo species with volume of One Hundred Twelve board feet (112 bdft.) and one (1) sthil chainsaw were confiscated.
- 4. However, it was stated by Alonzo Nava Minesterio on the administrative hearing conducted in November 7, 2022 that the chainsaw used was not registered to DENR due to assembled only.
- 5. The trees cut and sawn within the lot owned by Liza Hernandez, has no knowledge that his chainsaw was used by Alonzo Nava Minesterio on that day, October 23, 2022.
- 6. The subject forest products were turned-over by the apprehending officers to the DENR CENRO, authorized Seizure Officer pursuant to Section 3 of DAO 97-32

FINDINGS AND RECOMMENDATIONS:

The undersigned after having reviewed the documents at hand and the statements of the respondent and witness, and the Administrative Hearing conducted, determines that the SIX (06) pieces sawn lumber has no legal documents or papers from the DENR to warrant its transport or shipment. This act is in violation of Sec. 77 of PD. 705 as amended.

In view of the foregoing these are the findings and recommendations of the hearing officer:

ALONZO NAVA MINESTERIO., respondents for CENRO Case No.2022- 23 is violating Sec. 77 of PD 705 as amended hence:

- A. The SIX (06) pieces of sawn lumber **shall be forfeited** in favor of the government and **shall be disposed** in accordance with existing forestry laws, rules and regulations.
- B. As for the chainsaw used, the owner of the chainsaw has no certificate of registration of the act of the respondents on the day of apprehension.
- C. That upon verification in this office, the chainsaw has no certificate of registration issued and no serial number.

This case has been filed to the Regional Trial Court of Pinamalayan with *Criminal Case No. CR22-13134* for Violation of Sec.77 of PD 705 as amended by E.O. 277 and RA 9175. Any update in this Administrative Hearing will be given to the Regional Trial Court.





1. What: Violation of RA 9175 and PD 705

2. Where: Sitio Bulihan, Brgy. San Antonio, Gloria, Oriental Mindoro

3. When: October 23, 2022 at 2:10 PM

4. Who: The suspect was identified as Alonzo Naba Mesterio, 32 years old, married, chainsaw operator, and resident of Brgy. Manguyang, Gloria, Or. Mindoro.(Arrested)

5. How: Investigation disclosed that the personnel of Gloria MPS led by PLT MARVIN A HERNANDO, DCOP under the supervision of the undersigned conducted operation against Illegal Logging activity at Brgy. San Antonio this municipality and recovered three (3) pieces of 4x4x12, two (2) pieces 4x4x14 and one (1) piece of 3x8x14 with a total aggregate volume of sixty-two (62) board feet of illegally sawn lumber Antipolo tree with specie name Antocarpus Blancoi with total market value amounting to Two Thousand Seven Hundred Ninety Pesos (Php 2,790.00). Upon investigation of the said suspect, he failed to present any valid documents (permit to cut and permit to transport) from CENRO/MENRO proving the legality of his action. The chainsaw used during the said operation is an assembled one, with no chassis number and the operator has no document presented proving that it was registered from CENRO. The said operation was recorded through the use of Alternative Recording Devices (Boblov F1) in compliance with the Supreme Court Ruling. The said suspect was apprised of his Constitutional Rights and Anti-Torture Law. The arrested suspect together with the recovered lumber is now under the custody of this Station and proper coordination with the CENRO Roxas is undertaken for the processing of the said evidence as an exhibit.
