Attached is the transcript of the Minutes of the Administrative Hearing undertaken on the case Department of Environment and Natural Resources—versus— Edwin Tamayo Tianzon for violation of R.A. 9175 as amended. Please be informed that Administrative Hearing was conducted last October 4 and 25, 2022 in accordance with Item 2, Section 7 of DAO 97-32 which was attended by respondent, with the following observations:

- 1. Based on the spot report of the Municipal Police of Mansalay, they received a tip from Barangay Intelligence Network (BIN) that there was a person cutting a mango tree using a chainsaw at So. Iba. Brgy. Waygan, Mansalay, Oriental Mindoro.
- MPS Mansalay went to the area to verify the information. They saw Edwin in the act of cutting mango. Upon verification, the MPS Mansalay found out that the chainsaw has no permit.
- 3. An administrative hearing was conducted after the turn-over of the documents from the Municipal Police of Mansalay.
- 4. During the administrative hearing, Edwin Tianzon denied that he used the chainsaw. He was eating at his house when the police officers seized the chainsaw. He was told to go to their headquarters and bring chicken. When he arrived at the station, he was immediately detained. Also, he was told that they will take a video of him in the act of cutting mango.
- 5. As for Randy Eusebio, he only borrowed the chainsaw from Ian Joseph Salas and he will buy it once the registration is processed. He was at Romblon when the incident happened. He told Edwin not to use the chainsaw because the registration is expired. He will process it once he came back from Romblon.
- 6. The subject chainsaw was turned-over by the apprehending officers to the nearest authorized Seizure Officer pursuant to Section 3 of DAO 97-32.

Respondent not having opted for a regular preliminary investigation of the case against them, nor had executed a waiver pursuant to Art 125 of the Revised Penal Code, the determination of probable cause proceeded on the basis of the evidence at hand and submitted by the complaining police officers.

After going over the facts and evidences on record, the undersigned finds sufficient ground to indict both ARIEL CASTRO GURO and EDWIN TAMAYO TIANZON for the crime of VIOLATION OF RA 9175 or the Chainsaw Act of 2002 and that they should be held for trial.

WHEREFORE, the undersigned respectfully recommends the filing of separate Information for VIOLATION OF RA 9175 or the Chainsaw Act of 2002 against ARIEL CASTRO GURO and EDWIN TAMAYO TIANZON at the proper court.
