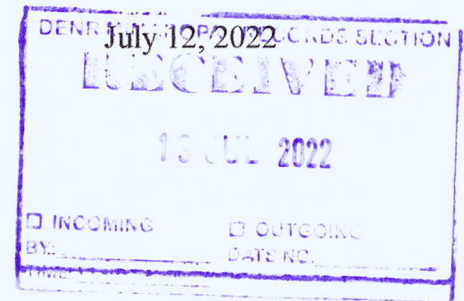

The PENR Office is within the subdivision owned by A & A Realty Development Enterprises Inc., located at Barangay Suqui, Calapan City. Apprehended and confiscated conveyances including its load forest products are impounded within the lots or vicinity of PENR Office, a private property of the herein firm.

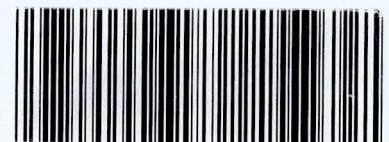
At present, the herein firm is on the process of developing the area by constructing gates and cementing of subdivision roads. In that regard, the said firm is advising our office to pull out all the apprehended/confiscated items within the subdivision lots.

Relative thereto, this office is requesting for the transfer of twenty six (26) conveyances loaded with illegally sourced forest products from PENR Office to Barangay Navotas, Calapan City. The estimated transportation cost is amounting to Php 111,000.00. This is based in the roughed estimate made by Jatulan Towing Services.
