A RESOLUTION DESIGNATING/ENDORISING FOR. MANUEL B. ROMERO AS OIC PROTECTED AREA SUPERITENDENT (PASu) OF MT. GUITING-GUITING NATURAL PARK

WHEREAS, it is within the powers, duties and functions of the Protected Area Management Board (PAMB) to approve policies, guidelines, plans and programs, proposals, agreements and other related documents, including the Manual of Operation for the efficient and effective management of Mt. Guiting-Guiting Natural Park (MGGNP);

WHEREAS, based on the Implementing Rules and Regulations (IRR) of Expanded NIPAS Act, *Section 11 – A. Powers and Functions of the PAMB, (k) the PAMB shall recommend from among a shortlist of qualified candidates, the designation or appointment of the PASu of a protected area.*

WHEREAS, based on the Implementing Rules and Regulations (IRR) of Expanded NIPAS Act, *Section 11 – B. Protected Area Management Office(PAMO),there is hereby established Protected Area Management Office (PAMO) to be headed by the Protected Area Superintendent (PASu) with a permanent plantilla position show shall supervise that day to day management, protection and administration of the protected area, and the PASu shall be primarily accountable to the PAMB and the DENR for the management an operations of the protected area.*

WHEREAS, during the 1st Quarter virtual PAMB Meeting of Mt. Guiting-Guiting Natural Park, PASu Malvin R. Rocero cited travel restrictions and huge amount of workload as OIC Chief, Management Services Division, as among the reasons that he cannot travel frequently to Sibuyan to personally supervise the management of the PAMO,

WHEREAS, during the 1st Quarter virtual PAMB Meeting, For. Manuel B. Romero was suggested to become an OIC PASu of Mt. Guiting-Guiting Natural Park for the time being.

WHEREAS, For. III Manuel B. Romero stated that he previously became a PASu of Mt. Guiting-Guiting Natural Park before becoming the Chief of Enforcement and Monitoring Section of PENRO Romblon, and National Greening Program (NGP) Coordinator at present.

WHEREAS, after due discussion, Hon. Rodne Galicia mentioned it is better to have an OIC PASu for Mt. Guiting-Guiting Natural Park while waiting for the shortlist of nominees for PASu;

WHEREFORE, premises considered after due deliberation and upon motion of Hon. Rodne Galica and duly seconded by Hon. Arthur R. Tansiongco and approved by majority members of the PAMB of Mt. Guiting-Guiting Natural Park; be it

RESOLVE as it is hereby resolve to designate/endorse For. Manuel B. Romero as OIC PASu of Mt. Guiting-Guiting Natural Park;

RESOLVED FINALLY, that copies of this resolution be furnished the Regional Executive Director, DENR MIMAROPA Region for her approval, and PASu, MGGNP for information and record.
