A RESOLUTION REQUESTING THE MIMAROPA REGIONAL EXECTUIVE DIRECTOR TO ISSUE CEASE AND DESIST ORDER ON THE APPROVED COMMERCIAL PERMIT OF MR. RONNEL GUTTIERREZ LOCATED IN SO. GAONG, TAMPAYAN, MAGDIWANG, ROMBLON AND REQUESTING THE MGB-PMRB TO INCLUDE PAMB CLEARANCE AS ONE OF THE REQUIREMENTS BEFORE THE ISSUANCE FOR APPROVAL OF ANY DEVELOPMENT PROJECT WITHIN SIBUYAN ISLAND

WHEREAS, it is within the powers, duties and functions of the Protected Area Management Board (PAMB) to approve policies, guidelines, plans and programs, proposals, agreements and other related documents, including the Manual of Operation for the efficient and effective management of Mt. Guiting-Guiting Natural Park (MGGNP);

WHEREAS, During the 4th Quarter PAMB Meeting, the issue of extracting of 10,000 cubic in So. Gaong, Brgy. Tampayan was reported by a concerned citizen to the barangay;

WHEREAS, Barangay Tampayan asked for assistance from the Office and the PAMB regarding the said extraction permit;

WHEREAS, after the overlaying of map with the coordinates stated in the permit, it was noted that 90% of the area for quarrying falls inside the Timberland area;

WHEREAS, on October 29, 2019 PAMB En Banc meeting a Resolution No. 2019-020 recommending the designation of timberland and agricultural land surrounding the Mt. Guiting-Guiting Natural Park as buffer zones of the protected area was passed;

WHEREFORE, premises considered after due deliberation and upon motion of Hon. Mirabelle Lanuza duly seconded by Hon. Darwin Ruado and approved by majority members of the PAMB of Mt. Guiting-Guiting Natural Park; be it

RESOLVE as it is hereby resolve to request the RED to issue cease and desist order on the approved commercial permit of Mr. Ronnel Guttierrez located in So. Gaong, Tampayan, Magdiwang, Romblon and requesting the MGB-PMRB to include PAMB clearance as one of the requirements before the issuance for approval of any development project within Sibuyan Island;

RESOLVED FINALLY, that copies of this resolution be furnished the Regional Executive Director, DENR MIMAROPA Region for her approval, the MGB-PMRB for their information and action, and PASu, MGGNP for their appropriate action, information and record.
