

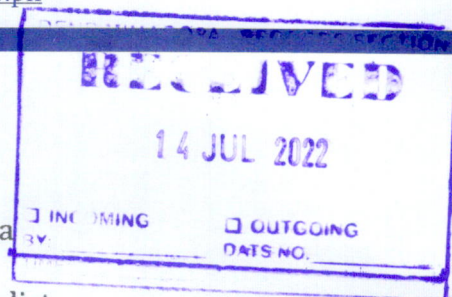

SUBJECT : **INVITATION TO THE 6th PHILIPPINE ASEAN HERITAGE PARKS
CONFERENCE ON 16-18 AUGUST 2022 IN DAVAO CITY**



The ASEAN Heritage Parks (AHPs) are protected areas of high conservation importance preserving in total a complete spectrum of representative ecosystems of the ASEAN Region. ASEAN Heritage Parks (AHPs) are established to generate awareness, pride, appreciation, enjoyment and conservation of ASEAN's rich natural heritage. AHPs are supported by the ASEAN through the AHP Programme which manages a regional network of representative protected areas created to generate a greater collaboration between ASEAN Member States in preserving their shared natural heritage.

As of today, there are 50 protected areas declared as AHPs spread throughout all the ten ASEAN Member States. Currently, there are nine (9) AHPs in the Philippines namely: Mts. Iglit-Baco Natural Park, Mt. Apo Natural Park, Mt. Kitanglad Range Natural Park, Mt. Malindang Range Natural Park, Tubbataha Reefs Natural Park, Mt. Hamiguitan Range Wildlife Sanctuary, Mts. Timpoong-Hibok-Hibok Natural Monument, Mt. Makiling Forest Reserve, and Agusan Marsh Wildlife Sanctuary. Except for the Mt. Makiling Forest Reserve, all designated AHPs in the country are part of the National Integrated Protected Areas System under the administration of the Department of Environment and Natural Resources.

The ASEAN Centre for Biodiversity (ACB) serves as the Secretariat of the AHP Programme and coordinates the management of the AHPs to generate a greater collaboration between ASEAN Member States in preserving their shared natural heritage. As designated by the ASEAN Secretariat, ACB provides technical advice and assistance to the Member States through the implementation of the Regional Action Plan for ASEAN Heritage Parks and facilitating several technical assistance grants from development partners.

1. To strengthen and promote management of AHPs in the Philippines, there were several conferences organized by this Bureau since 2010 involving the PASus and selected members of the Management Boards of the designated AHPs. This year, in preparation for the country's participation in the 7th ASEAN Heritage Parks Conference to be held in October 2022 in Indonesia, the Biodiversity Management Bureau intends to convene once again the AHP Managers and PAMBs on 16-18 August in Davao City. The 6th Meeting will serve as a venue to assess the role of AHPs/PAs in ecosystem protection and pandemic recovery through enhanced knowledge and skills on planning and implementing ecosystem management, restoration strategies, and building resilience, among others. Specifically, the Conference aims to:
 1. Improve the understanding and appreciation of the importance of AHPs in the conservation of biodiversity in the ASEAN;
 2. Assess the impact of COVID-19 pandemic in the Philippine ASEAN Heritage Parks;

3. Discuss and exchange experiences and practices on the management of AHPs;
4. Identify further activities to improve management of AHPs in the Philippines;
5. Promote partnership and networking among the AHPs in the Philippines; and
6. Prepare Philippine inputs to the 7th AHP Conference to be held on October 2022 in Indonesia.

Relative thereto and in view of the above objectives, may we invite you to participate in the said Conference.
