Respectfully forwarded the memorandum of CENRO Coron, Palawan dated June 14, 2022 relative the above subject.

Per memorandum, CENRO Coron received the copy of Order of Confiscation on May 27, 2022 of the apprehended twenty (20) pieces lumbers and nine (9) sacks of wood charcoal at So. Mayay, Barangay Sto. Niño, Busuanga, Palawan.

No criminal case was filed because there was an amicable settlement undertaken. Instead, the respondents were required to plant trees and render community service in their barangay to be supervised by the Barangay Chairman. Both accused submitted the notarized "Pinagsamang Sinumpaang Salaysay" on December 4, 2020. Further, the apprehended lumbers already deteriorated while the wood charcoal is already damaged.

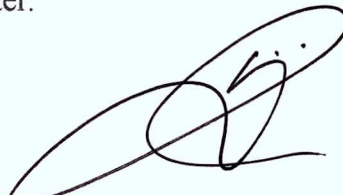
Please be informed that on May 27, 2022 this office received the copy of **ORDER OF CONFISCATION** dated April 11, 2022 of the apprehended twenty (20) pieces lumber and nine (9) sacks of wood Charcoal at So. Mayay, Brgy. Sto. Niño, Busuanga, Palawan.

Be informed further that the apprehended lumbers are already deteriorated while the nine (9) sacks of wood Charcoal are damaged.

This office cannot file a case against the offenders because during the administrative hearing, they (the offenders) asked an apology to Mr. Nilo Mariano and settled amicably. As a replacement of the trees they cut, he required them to plant trees and render community service in their barangay to be supervised by the Barangay Chairman. Furthermore, Mr. Mariano is in the United States at the moment. The offenders also submitted "*SINUMPAANG SALAYSAY*" (copy is hereto attached) regarding the matter.

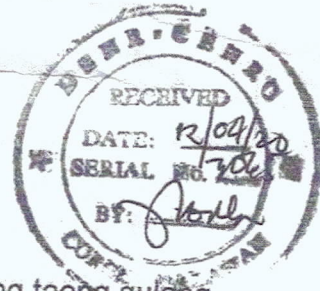

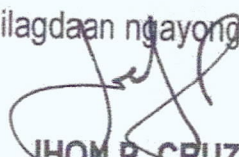


PINAGSAMANG SINUMPAANG SALAYSAY
