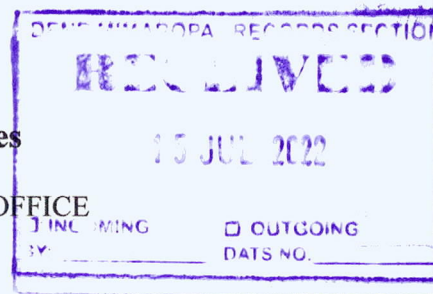

Respectfully forwarded is the memorandum of CENRO Roxas, Palawan dated May 25, 2022 relative the above subject.

Per memorandum, the apprehension was made by CENRO MES personnel (Patrol Sector II) while conducting anti-illegal operation on March 11, 2022 at around 11:00 A.M. in Purok Area 4, Barangay Sandoval, Roxas, Palawan.

The team apprehended the abandoned seventeen (17) pieces of Nato lumbers and one (1) piece Baan Kasko/Hull with equivalent volume of 455.99 board feet and estimated fair market value of Php26,740.00. The subject lumbers and hull were hauled and deposited at CENRO Compound under the custody of Forest Technician II/Property Custodian April N. Baltar.

Three (3) notices to the public were posted in public places on March 15, 2022, March 23, 2022 and March 31, 2022 in relation to Section 8, Item No. 3 of DAO 1997-32. However, no claimant appeared in the CENR Office. Hence, the absence of the owner/claimant to appear shall be deemed a waiver of their rights to the items apprehended in favor of the government.

We concur with CENRO recommendation for the issuance of confiscation order of the apprehended abandoned lumbers and hull.

Submitted herewith is the summary of the Administrative Confiscation Proceedings together with the pertinent documents anent the above-cited subject treated under DAO 97-32.

I. FACTS OF THE CASE

The apprehension was made by the DENR CENRO MES personnel (Patrol Sector II) on March 11, 2022 at around 11:00 A.M. while conducting anti-illegal logging operation in response to the received information from a concern citizen regarding the stack of lumber and a boat hull in the area. The abandoned apprehended forest products were brought to this Office compound for safekeeping under the custody of Forest Technician II April N. Baltar.

II. NOTICE OF HEARING

Pursuant to the provisions of the Department Administrative Order No. 97-32 Re: Rules of Administrative Adjudication of Illegal Forest Product and the Machinery, Equipment, Tools and Conveyance used in connection therewith specifically Section 08, Item No. 03, posting of Notice to the Public for the conduct of administrative hearing for three (3) consecutive weeks was conducted by this Office at the Barangay Hall of the concerned Barangay, Bulletin Board of the Sanguiang Bayan Bldg. Roxas and at the Receiving area of this Office.

After posting notice within the required period, no claimant has appeared on this Office. Hence, the absence of the owner/claimant to appear shall be deemed a waiver of their rights to the items apprehended in favor of the government.

IV. RECOMMENDATION

In view hereof, it is recommended that the seventeen (17) pieces of Nato lumber and one (1) piece of Baan hull (casco) with equivalent volume of 289.32 board feet and 166.67 board feet, respectively, be forfeited in favor of the government.

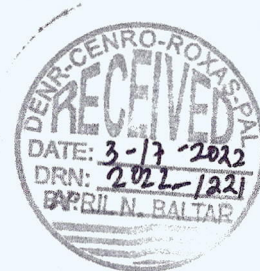

SUBJECT : **APPREHENSION OF ABANDONED LUMBER AND CASCO AT POROK AREA-4 BGY SANDOVAL, ROXAS, PALAWAN**



Please be informed that on March 11, 2022, the team together with FPSO assigned at Patrol Sector 2 conducted an operation in response to the concerned citizen information on a stack of lumber and a boat hull (casco) at Purok Area-4 at Bgy. Sandoval, Roxas, Palawan. The team started traversing a rice field nearby said area at Bgy. Sandoval, Roxas Palawan at around 10:00 A.M going to the location of the subject interior area of Purok Maharlika and arrived at around 11 a.m.

The team immediately conducted reconnaissance to locate the subject illegally sourced forest product. Eventually and witnessed the stockpile of undocumented forest product sourced from naturally grown timber of which sawn into lumber and boat hull. The team immediately conducted surveillance around the vicinity to find the perpetrator/s which might be just concealing somewhere nearby, but negative. At around 11 a.m., the team apprehended lumber with total volume of 455 board feet of lumber and boat hull. In the absence of perpetrators, the lumber was subjected to as abandoned. The apprehended forest products were immediately hauled to the DENR CENRO Roxas Compound for safekeeping and proper disposition.

Picture showing the Pabatid sa Publiko posted on the Bulletin Board of the Barangay Sandoval, Roxas, Palawan



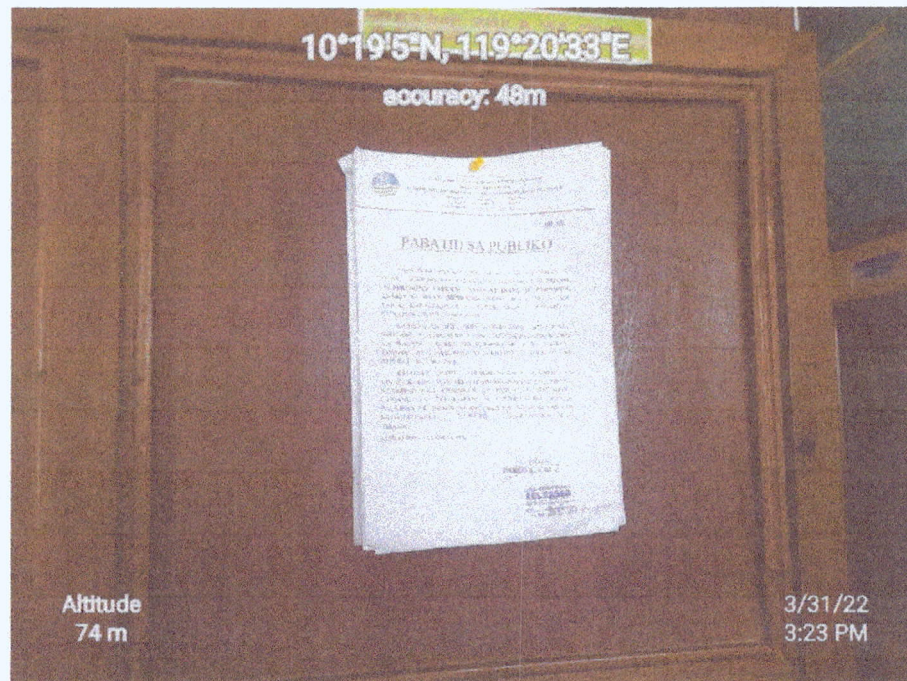
