

AS S/DENROS

In connection with the P/A/P Activate and Revitalize MFPCs, Individuals and Group Volunteers for Deputation as S/DENROs, CENRO San Jose, Occidental Mindoro through its Enforcement and Monitoring Section headed by Forester III Hector S. Aragones, Jr. conducted the Learning Event on the Important Environmental Laws, Policies, Rules and Regulation in Preparation for the Deputation of Individuals and Group Volunteers as S/DENROs on September 9-10, 2021 at Aroma Family Hotel and Resort Complex, Brgy. San Roque, San Jose, Occidental Mindoro. The said learning event to serve as a venue to capacitate individuals and group volunteers on the proper implementation of the environmental laws and policies as one of the primary requirements of deputation as S/DENROs.

The learning event were attended by IAMBAG Group, Harabas Team and CENRO San Jose Enforcement and Monitoring Section Staffs. The IAMBAG Group are volunteers from Ilin and Ambulong Islands of San Jose, Occidental Mindoro while the Harabas Team are a group of vloggers from Brgy. Mangarin, San Jose, Occidental Mindoro and both groups aim to be deputized as DENROs. There are a total of forty (40) participants composing of thirty five (35) males and five (5) females.

The program was hosted by Forester III Hector S. Aragones. The participants first introduced themselves following the topic of the first speaker Ecosystem Management Specialist II Ma. Teresita P. David, Jr. wherein she discussed the role of women as DENRO and Gender and Development (GAD). After that, Forester Aragones briefly discussed the Overview of the Environmental Status in the Philippines and the Province of Occidental Mindoro in which the participants were educated and informed that the protection of the environment must be prioritized. Forester Aragones also discussed the DENR Administrative Order No. 22 or the Revised Guidelines on the Deputation of Environment and Natural Resources Officer that applies to individuals or groups that are willing to be involved in the protection and conservation of the country's environment and natural resources through the issuance of a deputation order by the DENR. The Presidential Decree 705 or the Revised Forestry Code of the Philippines was briefly discussed by Forester Margie U. Ochoa, the Chief of Monitoring, Compliance and Investigation Section, Enforcement Division of DENR MIMAROPA Region via Zoom Meeting Application, Atty. Gandhi G. Gagni-Flores, the Chief of Legal Division of DENR MIMAROPA

Region discussed the Rules of Procedures of Case Filing and Prosecution on Environmental Cases. After that, an inspirational message was administered by OIC, CENR Officer Efren L. Delos Reyes to thank and appreciate the active participation of the participants.

The second day of the learning event was started by the recapitulation of the recent topics conducted by Forester Jomar B. Serguina, the Deputy Chief of Enforcement and Monitoring Section. Following that, Forester Aragones administered the open forum wherein the participants expressed their inquiries and astonishment towards being a Deputized Environment and Natural Resources Officer but all are very willing to officially volunteer as one. According to the participants, being a DENRO is a big challenge to their groups protection of the environment must be prioritized now. The Harabas Team who were residing at Brgy. Mangarin, San Jose, Occidental Mindoro pledged that they will protect the Mangrove Trees in their area and conduct Communication, Education and Public Awareness Campaign which they would likely include in their vlogs for people to be aware of the status of the environment. The IAMBAG Group from Ilin and Ambulong Islands, San Jose, Occidental Mindoro guaranteed that they will focus on the protection of their trees in their islands and to also apprehend the violators against the environment specially the illegal transportation of undocumented forest products. Both Harabas and IAMBAG groups show their support for the advocacy of the DENR and were motivated to protect the environment. The program was adjourned by DMO IV Wilfredo Aben sharing an important message to the participants for the protection of the environment and natural resources.
