

Background Information

Last 30 May 2022, a field campaign was conducted along the Benecan River in Brgy. Decalachao. Prior to the investigation in Eleanor's Happy Farm, one empty green dump truck was observed along the road. Based on the accompanying Forest Rangers of CENRO-Coron, the truck was owned by former SB Efren Tejada. Upon closer observation, the aggregates extracted from the river were delivered and piled approximately 130 m away from the source. Along the river, one backhoe was caught in the act of extracting aggregates.

Findings and Observations

- 1. The subject area is located along Benecan River, Brgy. Decalachao. Geographically at 12° 07' 44" N, 120° 07' 27" E. This is ~23 km away from CENRO which can be reached within an ~30-minute drive (Figure 1).
- 2. During the investigation in Eleanor's Happy Farm, an empty green dump truck was observed by the undersigned. The accompanying CENRO staff identified the owner of the vehicle to be the former SB Efren Tejada. With closer observation, a stockpile station was noted ~130 m away from the river source. Moreover, stacks of hollow blocks and a transport truck were observed (*see Photo Documentation*).
- 3. As the undersigned continued its investigation in Eleanor's Happy Farm, a backhoe and the, previously seen, green truck were caught in the act of extracting aggregates from the Benecan River channel (*see Photo Documentation*).

- 4. The undersigned visited the actual area and was greeted by Mr. Tejada (see Photo Documentation). He confirms that he is the owner of the truck and backhoe previously noted along the river. According to Mr. Tejada, the truck's capacity is ~15 cu. m. He mentioned that the aggregates quarried were used for the ongoing construction of his warehouse building in Sitio Dipolao, Poblacion 6, Coron. He also explained that none of the extracted sand and gravel were sold commercially.
- 5. Mr. Tejada further mentioned that he was a former subcontractor to certain projects of BCT Construction Inc. and previously supplied aggregates to the government water system projects.
- 6. The undersigned asked if he holds a permit to conduct such activity and he replied that he formerly holds a government gratuitous permit for his government-related projects, however, he admitted that at present he is extracting without a valid permit. ECC and SEP clearances were also requested but he also does not hold the following. The undersigned also reminded Mr. Tejada that he is operating within the Busuanga Pasture Reserve and exploitation in the area is deemed prohibited.
- 7. Mr. Tejada also mentioned about the plan, together with Mr. Fe Chi of Eleanor's Happy Farm, to rehabilitate the river back to its previous morphology prior to bridge construction (Figure 2).

Comments and Recommendations

 It was mentioned to Mr. Tejada that extracting without a valid permit is considered to be illegal. The undersigned recommended to secure first the necessary permits prior to sand and gravel extraction. In his case, given that the purpose is for a private project, an Exclusive Sand and Gravel Permit is suggested to be acquired and secured. As per Section 48 of Republic Act 7942, otherwise known as the Philippine Mining Act of 1995;

Any qualified person may be granted an exclusive sand and gravel permit by the provincial governor to quarry and utilize sand and gravel or other loose or unconsolidated materials from public lands for his own use, provided that there will be no commercial disposition thereof.

2. As to conducting extraction without a permit, this may constitute "Theft of Minerals" pursuant to Section 103 of RA 7942.

Theft of Minerals – Any person extracting minerals and disposing the same without mining agreement, lease, permit, license, or steals minerals or ores or the products thereof from mines or mills or processing plants shall, upon conviction, be imprisoned from six (6) months to six (6) years or pay a fine from ten thousand pesos (Php 10, 000.00) to twenty thousand pesos (Php 20,000.00), or both, at the discretion of the appropriate court. In addition, he shall be liable to pay damages and compensation for the minerals removed, extracted, and disposed of. XXX

3. In addition, the extracted materials are considered to be illegally sourced mineral/mineral products. Section 116 Chapter XII of DAO 2010-21 defines this as,

Illegally sourced minerals/mineral products are those which are mined, extracted, removed, and/or disposed of without the authority or permit under existing mining laws, rules and regulations.

- 4. For issuance of Notice of Violation for implementing a project without an approved Environmental Compliance Certificate (ECC) in violation of Section 4 of P.D. 1586.
- 5. The quarry site is also located within the BPR. This constitutes to violation of Presidential Proclamation No. 1387 and Presidential Proclamation No. 663. Any development activities within the BPR must acquire clearance from the Forest Management Bureau before any movements.

Whereas, Proclamation No. 1387 (s. 1975) withdrew from any form of disposition exploration or exploitation, and reserved as pasture reserve a parcel of land of the public domain in Busuanga, Palawan.

Repealing Proclamation No. 2057 and transferring the administration of the Busuanga Pasture Reserve to the DENR-Forest Management Bureau (DENR-FMB).

- 6. To endorse this to BPRMO for their proper evaluation of the violation of the proponent.
- 7. It is also suggested to the proponent that if he wishes to rehabilitate the area, consent from the PMRB must be granted. Furthermore, BPRMO must be informed prior to the rehabilitation activity.
