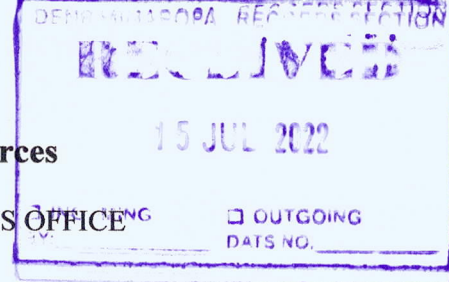

Respectfully forwarded is the memorandum of CENRO Roxas, Palawan dated May 25, 2022 relative the above subject.

Per memorandum, the apprehension was made by CENRO MES personnel (Patrol Sector II) in collaboration of NISG while conducting anti-illegal operation on February 28, 2022 at around 4:06 P.M. in Sitio Caybulo, Barangay Sandoval, Roxas, Palawan.

The team apprehended the abandoned one (1) unit chainsaw and one (1) piece Bayoso squared lumber with equivalent volume of 70 board feet with estimated fair market value of Php4,900.00. The subject equipment and lumber were hauled and deposited at CENRO Compound under the custody of Forest Technician II/Property Custodian April N. Baltar. Further, on March 10, 2022 the said chainsaw was properly turned over to the Office of Palawan Council for Sustainable Development (PCSD) pursuant to Paragraph 2, Section 9, of Republic Act 9175 or the Chainsaw Act of 2002.

Three (3) notices to the public were posted in public places on March 9, 2022, March 17, 2022 and March 25, 2022 in relation to Section 8, Item No. 3 of DAO 1997-32. However, no claimant appeared in the CENR Office. Hence, the absence of the owner/claimant to appear shall be deemed a waiver of their rights to the items apprehended in favor of the government.

We concur with CENRO recommendation for the issuance of confiscation order of the apprehended abandoned squared Bayoso lumber.

Submitted herewith is the summary of the Administrative Confiscation Proceedings together with the pertinent documents anent the above-cited subject treated under DAO 97-32.

I. FACTS OF THE CASE

The apprehension was made by the DENR CENRO MES personnel (Patrol Sector II) on February 28, 2022 at around 04:06 P.M. in collaboration with NISG while conducting anti-illegal logging operation in response to the intelligence report of illegal logging activity in the watershed in the Barangay Sandoval, Roxas, Palawan. The abandoned apprehended equipment was brought to this Office compound for safekeeping under the custody of Forest Technician II April N. Baltar on February 28, 2022 but was eventually turned-over to the PCSDS on March 10, 2022 pursuant to Section 9 of R.A. 7611. The squared wood of Bayoso tree spp. was also brought to the CENRO compound of Roxas, Palawan under the custody of Forest Technician II April N. Baltar.




In view hereof, it is recommended that the one (1) piece of Bayoso squared wood with equivalent volume of 70.00 board feet be forfeited in favor of the government.

Please be informed that on February 28, 2022, the team together with FPO Efren Esparagosa, Rexon Sanchez and Joven Benuja, and a representative from NISG conducted an operation in response to the intelligence report of illegal logging activity in the watershed at Bgy. Sandoval, Roxas, Palawan. The team started traversing from Bgy. Santo Tomas, Roxas Palawan at around 12:00 nn going to the interior of So. Caybulo, Barangay Sandoval, Roxas, Palawan and arrived at around 2:30 pm.

Upon arrival, the team witnessed the area of illegal cutting and we conduct immediate surveillance in the vicinity. While conducting the said activity, by chance at around 4:06 pm we apprehended a chainsaw and a lumber with total volume of 70 board feet. Due to the absence of perpetrator/s the chainsaw and the 70 board feet of lumber was subjected to as abandoned and brought to the DENR CENRO Roxas for safekeeping and proper disposition.

3. Offense Committed

- a. Violation of Section 77 of Presidential Decree No. 705 as amended by Executive Order No. 277 and Republic Act No. 7161 – **Cutting, gathering and/or collecting timber or other products without license.** Any person who shall cut, gather, collect, or alienable and disposable public land, or from private lands, without any authority under a license agreement, lease or permit, shall be guilty of qualified theft as defined and punished under Articles 309 and 310 of the Revised Penal Code.
- b. **Violation of Section 7 Paragraph 4 of Republic Act No. 9175 - Actual Unlawful Use of Chain Saw.** - Any person who is found to be in possession of a chain saw and uses the same to cut trees and timber in forest land or elsewhere except as authorized by the Department shall be penalized with imprisonment of six (6) years and one (1) day to eight (8) years or a fine of not less than Thirty thousand pesos (P30,000.00) but not more than Fifty thousand pesos (P50,000.00) or both at the discretion of the court without prejudice to being prosecuted for a separate offense that may have been simultaneously committed. The chain saw unlawfully used shall be likewise confiscated in favor of the government.
