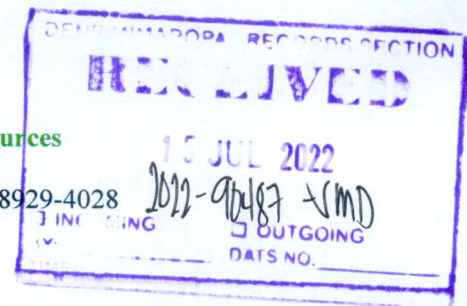

Respectfully referred herein letter sent thru email dated 16 June 2022, addressed to President Rodrigo Roa Duterte thru Dir. Jaime Llaguno Mabilin, Presidential Complaint Center (PCC) bearing Code No. **PL-NEM-06-22-2022-009**, transmitted to Office of the OIC DENR Secretary, and indorsed to the DENR Action Center/Hotline from Mr. Quirino D. Abrea <adquirino.795@gmail.com> pertaining to his request to conduct an investigation on the alleged land grabbing of their claimed parcel of land in Sitio Sia, Purok Milenyo, Brgy. Buenavista, Puerto Princesa City, Palawan by "armed land grabbers". The requesting party claims that this is in alleged connivance with the "DENR" as your PENRO Palawan purportedly approved the survey authority over the subject lot indicating its location in Brgy. Macarascas despite that it is in Brgy. Buenavista. Accordingly, this land grabbing incident is correlated with the Administrative Case No. M-02-20-1 filed by Mr. Abrea before the Ombudsman against a certain Engr. Marion Luenggo and Mr. Edgar Luenggo and several "DENR" employees for cancellation of approved Plan of Lot 68 SGS-044-000744-P, ignorance of the law, abuse of authority, incompetence, and dereliction of duty. Hence, this request, which merits for your appropriate actions, consistent with existing laws, rules and regulations.

Kindly inform directly the requesting party of action taken in this regard furnishing the PCC and this Office for monitoring/reference purposes. 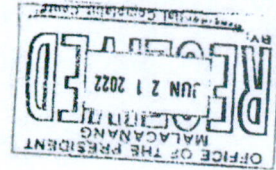
