SUBJECT : **ACCOMPLISHMENT REPORT ON THE ISSUANCE OF RESIDENTIAL AND AGRICULTURAL FREE PATENTS AS OF MARCH 31, 2021**

This refers to the Accomplishment Report on the issuance of Residential and Agricultural Free Patents as of March 31, 2022, of DENR-MIMAROPA which was culled out from the consolidated monthly accomplishment report provided to this Office by the Project Monitoring and Evaluation Division (PMED) of Planning and Policy Service (PPS).

Upon review and evaluation of the reported accomplishment, a total of eighty-nine (89) Residential Free Patents (RFPs) were issued. This represents seventy-five percent (75%) of the target for the 1st quarter of CY 2022, which is one hundred nineteen (119) RFPs. The region has a deficit of thirty (30) RFPs for the 1st quarter target. Based on your annual target of one thousand eighty (1,080) RFPs, your performance is eight percent (8%) overall. Likewise, on Agricultural Free Patents (AFPs), a total of twenty-seven (27) AFPs were issued. This represents one hundred sixty-nine percent (169%) of the target for the 1st quarter of CY 2022, which is sixteen (16) AFPs. The region overshoot the 1st quarter target by eleven (11) AFPs for the 1st quarter target. Based on your annual target of four hundred fifty-eight (458) AFPs, your performance is six percent (6%) overall.

However, it appears that based on your work and financial plan, the target for the 1st quarter is fifty-two (52) AFPs and not sixteen (16) AFPs as stated in the consolidated monthly accomplishment report. Also, it was declared that there are twenty-five (25) AFPs issued for the month of March. On the other hand, in the reported to-date accomplishment, there are twenty-seven (27) AFPs. Furthermore, you have rectified your Accomplishment Report for RFPs and AFPs, but there is no basis to support the verification of the same.

In view of the above evaluation, this Office recommends that the Region should consider evaluating the operational issues that affect the CENROs and PENROs performance and institute appropriate remedial measures to ensure 100% accomplishment of your targets for the issuance of both Residential and Agricultural Free Patents.
