CERTIFICATION

This is to **CERTIFY** that per records on file in this Office, an **ORDER** dated MAR 25 2022 was issued in the above-captioned case confiscating the twenty-two (22) pieces of lumber of White Lauan and Narra species and three (3) pieces of Kasko Haul of White Lauan species having an aggregate volume of 1.29 cubic meters (546.3 board feet), apprehended at Sitio Lendero, Barangay Marigondon Norte and Sur, San Andres, Romblon.

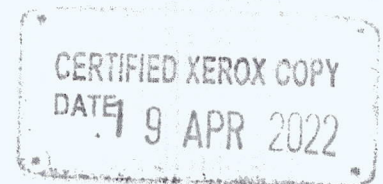
In compliance with Section 8(3), DAO 97-32, three (3) Notices of Hearing dated *December 6, 2021, December 13, 2021 and December 20, 2021*, over the apprehended items were posted for three (3) consecutive weeks in three (3) conspicuous public places in the locality.

Since no owner, claimant, or other interested party appeared at the proceedings, such failure to appear is deemed as a waiver of the right to appear and of any/all rights to the items apprehended in favor of the Government, as provided under Section 8(3), DAO 97-32.

Moreover, under Section 7, DAO 97-32, a Decision/Order shall become final and executory upon the lapse of fifteen (15) regular business days unless a Motion for Reconsideration is filed. Hence, the said Order is declared **FINAL AND EXECUTORY**. The confiscated items are deemed permanent property of the Government and shall be entered into the books of the concerned PENRO to be disposed of in accordance with the applicable laws, rules and regulations.

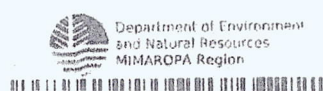



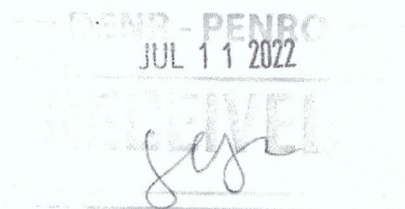

IN RE: CONFISCATION OF TWENTY-TWO (22) PIECES OF LUMBER OF WHITE LAUAN AND NARRA SPECIES AND THREE (3) PIECES OF KASKO HAUL OF WHITE LAUAN SPECIES HAVING AN AGGREGATE VOLUME OF 1.29 CUBIC METERS (546.3 BOARD FEET) APPREHENDED AT SITIO LENDERO, BARANGAY MARIGONDON NORTE AND SUR, SAN ANDRES, ROMBLON

ORDER

Records show that on December 2, 2021 at around 9:16 o'clock in the morning, at Sitio Lendero, Barangay Marigondon Norte and Sur, San Andres, Romblon, the elements of San Andres Municipal Police Station, San Andres Romblon, apprehended twenty-two (22) pieces of lumber of White Lauan and Narra species and three (3) pieces of Kasko Haul of White Lauan species having an aggregate volume of 1.29 cubic meters (546.3 board feet), with an estimated fair market value of PHP 20,120.00. The subject forest products has no claimant/s during the time of apprehension and were hauled and deposited at the DENR-PENRO Romblon compound for safekeeping. A Seizure Order and Seizure Receipt, both dated December 2, 2021 were issued PENRO Maximo C. Landrito, Seizure Officer.

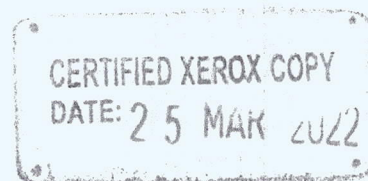
Pursuant to Section 8 of DAO 97-32, the PENRO concerned posted Notices of Hearing on *December 6, 2021, December 13, 2021 and December 20, 2021*, in conspicuous public places within the locality, informing the claimant/s to appear and show cause why the apprehended items should not be confiscated in favor of the government. However, despite said notices no one came to claim ownership of the same, hence considered "ABANDONED."

WHEREFORE, PREMISES CONSIDERED, the twenty-two (22) pieces of lumber of White Lauan and Narra species and three (3) pieces of Kasko Haul of White Lauan species having an aggregate volume of 1.29 cubic meters (546.3 board feet), with an estimated fair market value of PHP 20,120.00 apprehended at Sitio Lendero, Barangay Marigondon Norte and Sur, San Andres, Romblon, are hereby **CONFISCATED** in favor of the government to be disposed of in accordance with existing DENR laws, rules and regulations governing the matter.
