Per memorandum, CENRO Coron submitted the investigation report of MGB and EMB embedded personnel. The team found out that the reclamation started around 2019 and on the same year the Barangay Council immediately released an ORDER to stop the reclamation in the place due to lack of necessary permits/clearances from different concerned agencies by the project contactor, the JECO Development Corporation.

The proponent or contractor must secure first the Environmental Compliance Certificate (ECC) from EMB MIMAROPA, Geohazard Certification from MGB and other pertinent permits/clearances prior the continuation of the project.

RECLAMATION IN BRGY. TAGUMPAY, CORON, PALAWAN

This pertains to the instruction from CENRO-Coron dated 16 Mov 2022 to conduct an immediate investigation on the alleged illegal reclamation situated in Brgy. Tagumpay, Coron. This is in connection with a complaint received by the office.

The investigation was conducted on the same date where it is composed of the following personnel: Ms. Casandra Lynda Jalac of the Mines and Geoscience Bureau MIMAROPA Region, Mr. Arwin del Rosario, and Mr. Jonald Lenasic of the Environmental Management Bureau MIMAROPA Region. Kgwd. Benigno Gamboa of the said barangay assisted the undesigned during the inspection.

Background Information

According to the complaint received, there has been a recent reclamation activity in the mentioned barangay. However, the exact location was not provided by the complainant. The subject area was verified in the barangay and was found ~ 150 m away from the barangay hall. As mentioned, there has been recent dumping of earth materials in the area.

Based on the information gathered, this allegedly reclaimed land is a project of a certain private company. It started its reclamation activity around 2019 (see Annex-1) and in the same year, the barangay issued a stoppage order to the contractor. According to the barangay officials, this order was released due to their lack of the necessary permits/clearances from different offices. To add, the barangay was not also informed regarding the project and for what purpose it is. Furthermore, the Coron Municipal Engineering Office also confirmed that the contractor does not have any permission or appropriate documents from their office to conduct such activity.

Purpose and Scope

The investigation was conducted to verify the alleged reclamation in Brgy. Tagumpay. Additionally, to check the current situation of the site and recommend necessary actions.

Findings and Observations

1. The subject area is geographically located at 11° 59' 33" N, 120° 12' 40" E. This is situated within the jurisdiction of Brgy. Tagumpay (Figure 1). This is approximately three km away from CENRO which can be reached within five minutes of travel.

- 2. The undersigned first paid a courtesy to the barangay to discuss the purpose of the investigation (see Photo Documentation). A brief discussion with the barangay secretary and Kgwd. Gambao was conducted. Based on the barangay officials, they were not aware of the recent dumping in the subject area. No trucks were also observed passing during the day in the past few days. If given that the complaint is true, this allegation might have happened during the night as presumed by the barangay secretary. Kgwd. Gamboa further mentioned that the barangay has already issued a stoppage order in 2019 with which the contractor complied. This order, however, was not provided to the undersigned.
- 3. The undersigned further asked the barangay officials if they know the source of the filling materials. However, they have no idea who might the supplier be. Regarding the area, the barangay mentioned that it is private property but not titled to the contractor. The contractor only has a tax declaration for the said area.
- 4. At the subject area, Mr. Jumil Pistaño security officer, accompanied the undersigned during the inspection. No recent dumping of earth materials was noticed on the site.

Moreover, plants were already growing on the piles of aggregates, no tire tracks were spotted, and all the earth materials are also compacted (*see Photo Documentation*). These pieces of evidence only indicate that no recent activity occurs at the site. This was also confirmed by the officer on site. As mentioned by Mr. Pistaño, the contractor of this project is JECO Development Corp. Although, he has no idea about the plan and purpose of the site. The possible source of the filling materials was asked by the undersigned, but Mr. Pistaño also does not know where it came from.

- 5. The Municipal Engineering Office of Coron also confirmed that the JECO Development Corp. has not acquired any permit from their office (see Annex-2).
- 6. The size of the reclaimed land is approximately measured by the undersigned. Its dimension is 30 m long, 22 m wide, and 2 m in height (see Photo Documentation).

Comments and Recommendations

- Based on the result of the investigation, the project proponent is recommended to acquire the necessary permits/clearances from the different concerned government offices.
 - a. Environmental Compliance Certificate (ECC) from EMB MIMAROPA
 - b. Geohazard Certificate from MGB
 - c. Others
- 2. The proponent is also asked to explain/discuss where the earth materials were extracted. The CSAG/Quarry Permit should be provided together with the Delivery Receipts.
- 3. To CENRO-Coron, to issue a Notice of Violation if found necessary.
- 4. To the barangay, to closely monitor the subject area.
