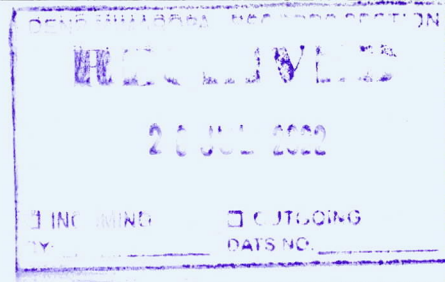

**Resolution No. 2022-005**

**RESOLUTION RESPECTFULLY REQUESTING LOMELYN E. CLAUDIO, REGIONAL EXECUTIVE DIRECTOR, DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) MIMAROPA FOR AN ASSISTANCE TO PRE-SURVEY AND ISSUANCE OF LAND TITLE TO RESIDENTS OF SITIO BACLARAN, BARANGAY PINAGTURILAN, MUNICIPALITY OF SANTA CRUZ, PROVINCE OF OCCIDENTAL MINDORO.**

**WHEREAS**, Sitio Baclaran is a developing residential area consisting of Three Hundred Sixty One (361) households with a population of One Thousand Four Hundred Forty Seven (1,447);

**WHEREAS**, most residents are living in the sitio for more than twenty years and more but unfortunately have no legal possession on their respective occupied lot;

**WHEREAS**, Republic Act No. 11573 ensures the continued titling of agricultural lands and mandates the CENRO of the DENR to facilitate applications of qualified occupants;

**WHEREAS**, this endeavour provides security of land tenure among the residents as well as encourage investment, increase tax collection in favour of both government and the community;

**WHEREAS**, mandated to promote public welfare, this request is earnestly sought;

**NOW THEREFORE**, on motion of Hon. Suzie I. De Lara, duly seconded by all Sangguniang Bayan Members present;

**RESOLVED**, AS IT IS HEREBY RESOLVED to respectfully request Lomelyn E. Claudio, Regional Executive Director, Department of Environment and Natural Resources (DENR) MIMAROPA for an assistance to pre-survey and issuance of land title to residents of Sitio Baclaran, Barangay Pinagturilan, Municipality of Santa Cruz, Province of Occidental Mindoro.
