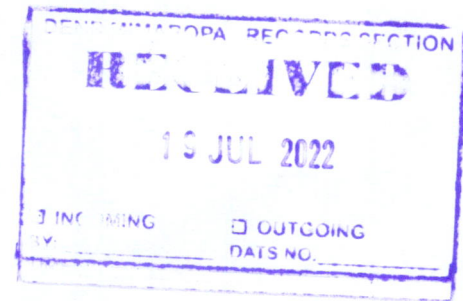

Dear Maam,

Greetings of Peace!

I am the heir daughter of Edgardo Jener and representative of 4 Stewardship located in So. Palisungan, Tagumpay Cerron Palawan containing 12 hectares of land divided into four siblings. These are the following CSC members, Edgardo Jener CSC # 2301776, Angelina Bandual CSC # 42301773, Lelanes de Guzman CSC # 42301774, Benvirinas Jener CSC # 42301773.

Our Stewardship was expired last October 2016. We did not renew it and plant some additional trees because my father died of cancer and followed by pandemic.

Last June 14, 2022, DENR invited me for a dialogue with DIC Rodney Verian and

Forester Glen Managdag. They confirmed that we have one year grace period to plant some trees that needed for our CSC renewal.

We had a small talk to Ms. Marilyn Blasa of DENR Puerto and finalized our plans for coffee plantation over the phone with Forester Glen.

A good source of coffee in the Philippines and also can benefit the lives of the people in Balisungan.

We informed the Barangay Captain about this. and during our operation Barangay Captain stopped us. We have 7,000 coffee plants and Mahogany half of it is critical to die because He stop the operation.

We talked over text as He cannot answer the call. Barangay Captain informed me to send representative to Barangay and asking me to secure any permit to plant in the area. Our representative went to his office several times but He was not there.

Barangay Captain is requiring me to have an endorsement as He thinks that our Stewardship was expired.

We talked to DENR Caron, They said that they do not give certification as we are the actual owner of the land.

Please help us and shed light what to do as the Barangay Captain give us the hard time to renew it. They knew that our Stewardship was expired hoping that they can get it from us.

I am worried that there are 7000 Coffee Seedlings in the area and there are people who guard the place and not allow us even water it. We are told that it was ordered by Barangay Captain Chiff Aston. DENR told us that He has no right to stop us as we are the actual owner of the land. We are advised by the DENR to continue planting the coffee.

May I ask from your good office ^{Army} ~~the~~ encroachment in any status about our renewal so that I can show it to Barangay Captain Cliff Astor.

There was an actual survey being done and relocation of boundaries of our property and the property adjacent to us. It was conducted by three representative of DENR headed by forester Glen Managdag and our representative Ramfel Leus and Marlo Gesta. It was evaluated and we need some improvements to facilitate our renewal. We wanted to have a smooth and safe operation for plantation of Coffee.

This evaluation identifies our actual boundaries that we identify the 4 people namely Viola Agondes, Marilyn Aguilan, Wilfredo Aularan who do illegal fencing in the land adjacent to us that enters Gesta property.

Our evaluation was made by Forester Glen and was sent to Barangay Captain Cliff Astor for signature. Unfortunately it was send back to Forester Glen. And we are informed that there will be a second assessment and evaluation. Why do we need a second evaluation? When the second assessment are being done, these people came out and claim our cashew trees. From fencing illegally to Gesta property they transfered to us.

Our cashew trees was planted by my father. Our property was develop by my grandfather since 1947. As of ^{that} time my grandmother was the owner of 55 hectares of land that being divided to the Siblings. Ms Rubio Rafael the oldest man there can testify. Barangay Captain Allowed the illegal Settlers without any papers to claim and continue fencing and make a house in the area while ^{we are} waiting for his signature for our renewal. Its been 9 months now that he did not make any endorsement to solve this case.

I am sending you the copy of the complain by Gesta family in the Barangay as they are fencing illegally and now trasfered in our property.

They are being ejected in Gesta property as they are no papers to show in the Barangay hearings.

These people are the one who harassed our planters and they said it was ordered by Barangay Captain to stop us.

I am sending you the copy of text messages of Forester Glen and Captain Astor.

We are fearful that our one year chance to plant given by DENR will be over.

I even went to Puerto Princesa and talked to Maam Merlyn Blase over this as Captain Astor dont sign our application.

I was informed by Maam Merlyn that the 3.3 hectares no ~~need~~ need of Captain Astor Signature.

Barangay Captain has no right to mediate regarding the renewal of CSC. And even stop the plantation. Its against the program of DENR that you stop reforestation. He must be liable on this.

We are ~~ha~~ being harassed by the squatters that the Captain protect them as they are considered as "botante" for upcoming elections.

Please help us protect the forest land as there is rich chinese people wanted to buy the land. Mr. Wong.

The tagbannas are being used to become front as some government officials abuses their power to claim and grab the land.

The squatters being reported by Forester Giten in his evaluation in our property has no

Credibility and have some issues in the Surrounding Property for illegal squatting.

May I inform you also that during our second hearing in Barangay conducted by Kapitan Astor attended by Forester Glen. It was discussed in the hearing that Angelina and Dolores Stewardship will be divided into 14 people, in order for us to continue renewing our property Edgardo. That we do not agree.

We know our right as a CSC holder that we cannot sell, give and transfer the land to anybody. Forester Glen should stop from there about the issues of division of land. They don't have the right to award the land and he is only a Barangay Captain that his "mandato" is until 60^{days} only. If he cannot do anything he will endorse it to DENR. The scenario worsen because of failure to do his job. The people are expecting to give them Barangay Certification.

I am hoping that you can do something
to secure us and give us support as a
CSC holder, that we can plant peacefully.
