Trend in Threats

Based on report generated from SMART Software, the trend in threats shows decreasing from 0.13 in April to 0.04 in mid-June, it means effective forest protection.

April 6, 2022

Apprehended 22 pieces of abandoned Apitong and Malamangga lumber with different dimension (103.66 Bd. Ft.) at Sitio Barok, Cataban, Taytay, Palawan.

April 19, 2022

Apprehended of 309.74 Bd. Ft. Amugis and Ipil, seven (7) door jamb and 14 window jamb at Sitio Kamago, Barangay Bebeladan, El Nido, Palawan.

April 21, 2022

Investigated the Slash and Burn farming (Kaingin) in Sitio Pinagkulitan, Bgy. Mabini, El Nido, Palawan. Recommended for filing of case.

April 27, 2022

Investigated the Slash and Burn farming (Kaingin) in Sitio Taberna, Bgy. Bucana, El Nido, Palawan.

May 16, 2022

Apprehended 21 of abandoned Ipil lumber with different dimension (500.66 Bd. Ft.) at Sitio Omao, Bgy. Bagong Bayan, El Nido, Palawan.

May 26, 2022

Investigated Slash and Burn farming (Kaingin) at So. Ngalan, Bgy. Pularequen, Taytay, Palawan.

June 8 and 10, 2022,

This reports presents trends in observations of forest condition, regeneration, threats and indicator species. The combined presentation allows for an evaluation if protection efforts are effective, conservation targets are met and the forest achieves the desired future forest condition. Protection efforts are effective, when records of forest condition, regeneration and indicator species show an upward trend towards more observations more and denser regeneration, particularly in degraded forest areas. Increasing trends in indicator species suggest that the improved forest condition is providing a better habitat for forest dependent species. All trends presented are put in relation to the patrol effort to provide comparability. Forest cover data were derived from 2003 and 2010 NAMRIA land cover maps.


Trends of Observations per Patrol Kilometer in the Forest Conservation Area


An increasing trend in indicator species in the forest conservation area means effective forest protection; a decreasing trend means the opposite.


