Respectfully forwarded the memorandum of CENRO Coron, Palawan dated June 20, 2022 relative the above subject.

Per memorandum, CENRO Coron submitted the Lawin Patrol Plan for 3rd Quarter of 2022 within the Forestland/Conservation Areas that includes portions of Busuanga Pasture Reserve (BPR) that are considered prone to poaching as part of monitoring and augmentation activities.

CENRO Coron has a quarterly patrol target of 150 kilometers and a monthly target of 50 kilometers. Fifteen (15) active/permanent patrollers duly assisted by four (4) volunteers (job order) compose the LAWIN Patrol Team. They cover the municipalities of Coron and Busuanga, Palawan.


