This pertains to the target 001 Patrolling under Maintenance and Protection of Coastal and Marine Ecosystem for El Nido-Taytay Managed Resource Protected Area (ENTMRPA), El Nido, Palawan.

Please be informed that the undersigned along with the Park Rangers and Forest Protection Officers of this office conducted seaborne patrol at within the jurisdiction of the protected area having covered eleven (11) sites (Corong-corong Bay, Entalula Island, Pangulasian Island, Snake island, Cudugnon Cave, Debuluan Island, Cathedral Cave, Lagen Island, Malapacao Island, Pinagbuyutan Island and Depeldet Island) and an approximate patrol distance of 36.7 kilometers based on locus map tracking and GIS projection.

The patrol starts at about 8:51 in the morning. The undersigned conducted briefing on the said activity. The team was composed of ENTMRPA Park Rangers and Forest Protection Officers namely: Henry Gabayan (Boat Captain); Jovan Villanueva (Helper); Ryan Cacacha; Reden Latube; Jeremei Ortega; and Joao Abus.

During the patrol, the team recorded and observed the following:

- A total of four (4) tourist boat conducting island hopping activities at Cudugnon Cave (2 boats), Cathedral Cave (1) and Sandbar near Aberawan (1);
- A total of three (3) small fishing vessel near Pangulasian Island, mainland of Bebeladan and Snake Island;
- Approximately three (3) Dolphin were observed between Debuluan Island and Cathedral Cave particularly at coordinates: N 11° 04.326', E 119° 22.334'.

With the result of this activity, the undersigned recommends continuous patrolling and monitoring activity in the area. A separate report on the apprehended compressor fishing activity at CENRO Taytay-El Nido.



This pertains to the target 001 Patrolling under Maintenance and Protection of Coastal and Marine Ecosystem for El Nido-Taytay Managed Resource Protected Area (ENTMRPA), El Nido, Palawan.

Please be informed that the team led by Park Ranger Patchito V. Dela Torre conducted seaborne patrol and covered an approximate patrol distance of 7.5 kilometers. During the patrol, the team discovered a fishpond within the mangrove areas allegedly owned by a certain Mr. Aguido Cotamura of Barangay Manlag, El Nido, Palawan. Upon initial investigation, Mr. Cotamura was not able to present his permits and pertinent documents to the team.

With the above findings, the team recommends the following:

- 1. Conduct continuous patrolling and monitoring on the coastal and mangrove areas within ENTMRPA;
- 2. Conduct in-depth investigation with assistance from CENRO Taytay technical personnel on the said developed fishpond within mangrove area of Barangay Manlag, El Nido, Palawan.

In compliance instructed by Protected Area Superintendent (PASu) Mildred A.Suza, El Nido Taytay Managed Resource Protected Area (ENTMRPA), to conduct patrolling and mangrove monitoring against illegal activities within ENTMRPA El Nido Palawan.

Please be informed that on June 14, 2022. The undersigned Park Rangers together with Forest Protected Officer (FPO) of ENTMRPA namely Nolan Llanera, Michael Espinosa, Ellezar Dolliente, Ernie Sakay and with the assistance of Barangay tanod of Barangay Manlag, El Nido Palawan conducted patrolling and monitoring of mangroves from View deck area of Sitio Lugadia Barangay Corong-corong to Sitio Danat Barangay Manlag El Nido Palawan.

The team patrolled about 7.5km. During the activities, the team was discovered the fishpond which located at Sitio Manlalic, Barangay Manlag. The team immedialety conduct initial investigation, which we known that the said fishpond was owned by Mr. Aguido Cotamura a resident of Barangay Manlag. His fishpond was found along the mangrove areas and he didn't presented any permit or documents to the team. This fishpond was more or less 925meters.

As per recommendation: The said illegal fishpond need inspection from CENRO Taytay Personnel's to conduct deep investigation about it.
