





Attached is the transcript of the Minutes of the Administrative Hearing undertaken on the case *Department of Environment and Natural Resources –versus- Romeo Masculino* for violation of Section 77 formerly Section 68 Presidential Decree 705 as amended by Executive Order 277 series of 1987. Please be informed that Administrative Hearing was conducted last June 28, 2022 in accordance with Item 2, Section 7 of DAO 97-32 which was attended by respondents, with the following observations:

1. Based on the spot report of the Municipal Police of Gloria, they received a tip from a concerned citizen that Romeo Masculino was seen cutting lumbers at So. Bulaklakan, Manguyang, Gloria, Oriental Mindoro.
2. MPS Gloria led by PLT Marvin A. Hernando went to the area to verify the information. Thereafter, they saw Romeo Masculino using the chainsaw while cutting the Gmelina Tree. They asked him who is the owner of the tree and whether he has a cutting permit and registration for the use of the chainsaw.
3. Romeo Masculino answered that Estelito Cabral owned the tree. That he has only certificate of registration for the chainsaw but no cutting permit.
4. During the administrative hearing, Romeo Masculino admitted that he cut the tree under the instruction of Estelito Cabral. That he has no cutting permit but only certificate of registration for the chainsaw.
5. The subject sawn lumbers of Mahogany and Gmelina were turned-over by the apprehending officers to the nearest authorized Seizure Officer pursuant to Section 3 of DAO 97-32.

FINDINGS AND RECOMMENDATIONS:

The undersigned after having reviewed the documents at hand and the statements of the respondents, and the Administrative Hearing conducted, determines that the THIRTEEN (13) pieces sawn lumbers (Mahogany and Gmelina species) with a total volume of 78 board feet has no legal documents or papers from the DENR to warrant the cutting, gathering and/or possessing the same. This act is in violation of Sec. 77 of PD. 705 as amended.

In view of the foregoing these are the findings and recommendations of the hearing officer:

ROMEO MASCULINO respondents for CENRO Case No. 2022- 14 violated Sec. 77 of PD 705 as amended hence:

The THIRTEEN (13) pieces sawn lumbers with a total volume of 78 **shall be forfeited** in favor of the government and **shall be disposed** in accordance with existing forestry laws, rules and regulations.

This case has been filed to Regional Trial Court-Pinamalayan with Criminal Case No. CR22-11993 for Violation of Sec.77 of PD 705 as amended by E.O.277.

1. What: **Violation of PD 705 (Illegal Logging)**
2. Where: Sitio Bulaklakan, Brgy. Manguyang Gloria, Or. Mindoro.
3. When: June 19, 2022, at about 5:15 PM.
4. Who: The suspect was identified as **Romeo Palermo Masculino**, 54 years old, married, chainsaw operator and resident of Brgy Manguyang, Gloria, Oriental Mindoro.(arrested)
5. How: Investigation disclosed that the team led by PLT MARVIN A HERNANDO, DCOP of this station under the supervision of the undersigned conducted an operation against Illegal Logging at Brgy. Manguyang, this municipality and recovered three (03) pieces of 2x3x12, two pieces of 2x4x12, two (2) pieces of 2x2x12 and one (1) piece of 4x4x10 all sawn mahogany lumber and also recovered were two pieces 2x2x8, two pieces 2x3x8 and one piece 4x4x10 of gemelina sawn lumber with a total aggregate volume of **eighty one (81) Board Feet** of illegally sawn lumber with a total market value amounting to Two Thousand Nine Hundred Sixteen Pesos (**Php 2,916.00**). Upon investigation of the suspect, he presented a valid certificate of registration of the chainsaw but no valid documents of permit to cut from CENRO proving the legality of his action. Alternative Recording Devices (Boblov F1) is used for the documentation of the said operation as a requirement in compliance with the Supreme Court Ruling. The suspect and the recovered sawn lumber are now under the custody of this station. The arrested person was apprised of his constitutional rights and Anti-Torture Law. Proper coordination with the CENRO Roxas is undertaken for the processing of the said evidence as an exhibit.
