Forwarded herewith the Order issued by Presiding Judge, Erwin Y. Dimayacyac regarding the apprehended vehicle loaded with lumbers on January 11, 2022 by this office.

The court finds the accused guilty beyond reasonable doubt for violation of section 3 of PD 953 and requiring them to pay a fine of P 5, 000.00 pesos each. Likewise, the vehicle and its load shall be disposed in accordance with DENR rules and regulations.

ORDER

This case was called for pre-trial. Attached on record is a Plea Bargaining Proposal filed by both accused through counsel. The prosecution gave its consent last April 12, 2022 for violation of section 3 of PD 953. Both parties agreed that both accused would withdraw their plea of not guilty and would plead guilty to a lesser offense for violation of section 3 of PD 953. The agreement of both parties was submitted to this Court for approval. Considering that their agreement is not against public policy, the same is hereby granted.

The previous plea of not guilty of both accused were withdrawn per motion of Atty. Gaudencio Sadicon. Accused were re-arraigned under the same Information qualified for violation of section 3 of PD 953 with the assistance of their counsel de parte, Atty. Sadicon by reading to them in a language and dialect known and understood by them, and accused entered a plea of not guilty. Finding the voluntariness of the plea of guilt of both accused, they should be convicted.

WHEREFORE, this Court finds both accused guilty beyond reasonable doubt for violation of section 3 of PD 953. They are hereby directed to pay a fine of ₱5,000 each. The lumber subject of this case be disposed in the manner provided by law. The tricycle used in gathering and transporting the lumber likewise be disposed under the DENR's rules and regulations.
