Relative thereto, please be reminded of the following requirements to be submitted online before requesting for the conduct of GIS analysis and or/ final map preparation for the CBFMA applications, to wit:

Shapefile of the area subject for CBFMA application (.shp);

2. Technical Description in Bearing - Distance (.xls or .xlsx), with the description of tie point and tie line:

3. Area Computation (.xls or .xlsx); and

Computed coordinates of the corners (.csv)

Be reminded further of the following:

1. Presence or overlapped with Alienable and Disposable (A & D), mineral lands and protected area. Please exclude these overlapped areas in the CBFMA application.

2. Presence or overlapped with NGP plantations which are not established by the CBFMA applicant. As much as possible, please exclude these overlapped areas in the CBFMA application. Further, if these areas will still be included, please attach the Certificate of Waiver from the contractor of the subject NGP plantation and/or the Certificate of Acceptance and Certificate of Turn-over consistent with the provisions of the Government Accounting Manual (GAM), particularly Volume 1, Chapter 10, Section 32, as prescribed under COA Circular no. 2015-0007 dated 22 October 2015. This is to ensure that possible conflict will be avoided among NGP contractor and CBFMA holder in the future especially when the said plantations are already harvestable.
