### PETITION

Petitioner, UZZIEL R. DE MESA, through counsel, most respectfully states:

- 1. Petitioner Uzziel R. De Mesa (hereinafter, "De Mesa"), is of legal age, Filipino citizen, single, and resident of Barangay Calero, Calapan City, Oriental Mindoro. For reasons of expediency and practicality, notices, processes, and decision of this Court may be served to petitioner through counsel at the address provided below.
- 2. Nominal respondent Registry of Deeds for Calapan City, Oriental Mindoro (hereinafter, "Registry of Deeds") is a land Registration Authority's field office in Calapan City, Oriental Mindoro, and in possession of the original copy of Transfer Certificate of Title (hereinafter, "TCT") No. 064-2021002314<sup>1</sup>. Summons and other court processes may be served to respondent Registry of Deeds at the Office of the Registry of Deeds, Barangay Sta. Isabel, Calapan City, Oriental Mindoro.
- 3. Petitioner De Meca is the registered owner of a 307 sqm parcel of land situated in Block 6, Sta. Maria Village, Calapan City, Oriental Mindoro (hereinafter, "SMV Lot"), and embraced by Transfer Certificate of Title (hereinafter, "TCT") No. 064-2021002314, of the Registry of Deeds for Calapan, Mindoro Oriental. The SMV Lot is declared under Tax

- 4. The SMV Lot is adjacent<sup>3</sup> to the following land holdings: Lot No. 2-B-1-F-2<sup>4</sup>; Lot No. 1 (PCS-12659)<sup>5</sup>; Lot No. 2-B-1-I<sup>6</sup>; and Lot No. 2-B-1-G<sup>7</sup>.
- 5. Appearing on page (3) of TCT No. 064-2021002314 are the following annotations:

"PURSUANT TO SECTION 7 OF REPUBLIC ACT NO. 26, THIS CERTIFICATE OF TITLE HAVING BEEN ADMINISTRATIVELY RECONSTITUTED IS WITHOUT PREJUDICE TO ANY PARTY WHOSE RIGHT OF INTEREST IN THE PROPERTY WAS DULY NOTED ON THE ORIGINAL HEREOF AT THE TIME IT WAS LOST OR DESTROYED.

"IT IS HEREBY CERTIFIED THAT THIS CERTIFICATE OF TITLE CONSTITUTING OF TWO (2) PAGES ON THIS DATE, 01-03-78 HAS BEEN RECONSTITUTED FROM ITS OWNER'S DUPLICATE THE RECONSTITUTION HAVING BEEN EFFECTED ADMINISTRATIVELY UNDER THE PROVISIONS OF REPUBLIC ACT NO. 26.

6. Under Republic Act (hereinafter, "R.A.") No. 26 (Amended), the registered owner, upon the lapse of two (2) years from the date of reconstitution may ex parte move for cancellation of the annotation made pursuant to Section 7 of the same law:

SECTION 9. <u>A registered owner</u> desiring to have his reconstituted certificate of title freed from the encumbrance mentioned in section seven of this Act, may file a petition to

that end with the proper Court of First Instance, giving his reason or reasons therefor. A similar petition may, likewise, be filed by a mortgagee, lessees or other lien holder whose interest is annotated in the reconstituted certificate of title. Thereupon, the court shall cause a notice of the petition to be published, at the expense of the petitioner, twice in successive issues of the Official Gazette, and to be posted on the main entrance of the provincial building and of the municipal building of the municipality or city in which the land lies, at least thirty days prior to the date of hearing, and after hearing. shall determine the petition and render such judgment as justice and equity may require. The notice shall specify, among other things, the number of the certificate of title, the name of the registered owner, the names of the interested parties appearing in the reconstituted certificate of title, the location of the property, and the date on which all persons having an interest in the property must appear and file such claim as they may have. The petitioner shall, at the hearing, submit proof of the publication and posting of the notice: Provided, however, That after the expiration of two years from the date of the reconstitution of a certificate of title, if no petition has been filed within that period under the preceding section, the court shall, on motion ex parte by the registered owner or other person having registered interest in the reconstituted certificate of title, order the register of deeds to cancel, proper annotation, the incumbrance mentioned in section seven hereof." (Underscore supplied.)

- 7. The predecessor of TCT No. 064-2021002314 was administratively reconstituted on January 3, 1978.
- 8. Section 9, R.A. 26 (Amended), allows a reconstituted title to be freed from encumbrance mentioned under Section 7, of the same law, after the lapse of two (2) years from reconstitution. After more than forty-four (44) years since the administrative reconstitution of the forerunner of TCT No. 064-2021002314, no petition in accordance with the provision of Section 8, R.A. No 29 (Amended) was filed or annotated on said titles. Hence, the cancellation of annotation pursuant to Section 7, R.A. No 26 (Amended) appearing on TCT No. 064-2021002314 is warranted.
- 9. The real estate taxes due to the SMV Lot were all paid prior to the filing of this petition.
- 10. To substantiate petitioner's cause she will testify as the registered owner of TCT No. 064-2021002314 and that no petition in accordance with Section 8, R.A. No. 26 (Amended) was filed or annotated

on the latter title. Petitioner shall likewise testify on other matters which are material and relevant.

- 11. During the course of the hearing of this petition, petitioner VAC will present in evidence the following documents:
  - a. True electronic copy of TCT No. 064-2021002314,
  - b. Tax Declaration TD No. 21-054-00923, and
  - c. Real Property Tax Receipt No. 197549

### RELIEF

Wherefore, in view of the foregoing, and in accordance with Section 9, Republic Act No. 26 (Amended), petitioner most respectfully prays for this Honorable Court to order the Registry of Deeds for Calapan, Mindoro Oreintal, to cancel and remove the annotations, inscribed pursuant to Section 7, Republic Act No. 26 (Amended), on TCT No. 064-2021002314.

Petitioner likewise pray for such other reliefs just and equitable under the circumstances.

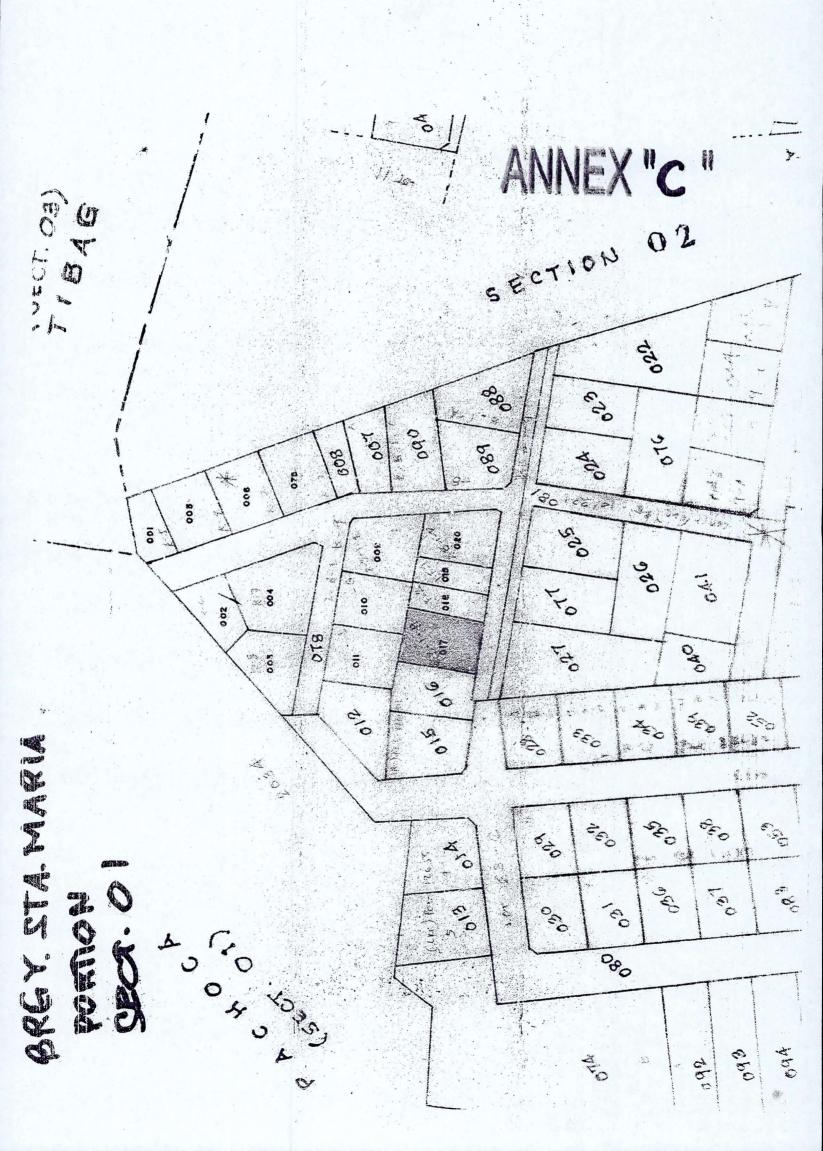
