

This pertains to the target 001 Patrolling under Maintenance and Protection of Coastal and Marine Ecosystem for El Nido-Taytay Managed Resource Protected Area (ENTMRPA), El Nido, Palawan.

The team conducted seaborne patrol within ENTMRPA and covered eight (8) sites with an approximate patrol distance of 63.2 kilometers base on locus map tracking and GIS projection. During the patrol, the team apprehended four (4) individuals in the act of conducting compressor fishing near Jip Rocks, Barangay Bebeladan, El Nido, Palawan. Apprehended/seized compressor and paraphernalia were inventoried and being kept at Divers House located at Barangay Corongcorong, El Nido, Palawan.

This office recommends continuous patrolling and monitoring within the protected area. A separate report will be submitted pertaining to the said apprehension.

PROTECTED AREA (ENTMRPA) ON JUNE 10-11, 2022

This pertains to the target 001 Patrolling under Maintenance and Protection of Coastal and Marine Ecosystem for El Nido-Taytay Managed Resource Protected Area (ENTMRPA), El Nido, Palawan.

Please be informed that the undersigned along with the Park Rangers and Forest Protection Officers of this office conducted seaborne patrol at within the jurisdiction of the protected area having covered eight (8) sites (Cadlao Island, Dilumacad Island, Tapiutan Island, Matinloc Island, Turtle Island, Limangeong Pinaglugaban Island, Shimizu Island and Jip Rocks) and an approximate patrol distance of 63.2 kilometers based on locus map tracking and GIS projection .

June 10, 2022; 11:20 AM. The patrol starts at about 11:20 in the morning. The undersigned conducted briefing on the said activity. The team was composed of ENTMRPA Park Rangers and Forest Protection Officers namely: Eleazar Dolliente (Boat Captain); Jovan Villanueva (Helper); Manuelito Jongay; Anthony Escala; Jerremeil Tacob; Jeremei Ortega; Joao Abus; Nolan Llanera; and Jesrel Dalojo.

June 10, 2022; 12:13 AM. From Corong-Corong Bay, the team traversed Ipil Beach, Papaya Beach and Seven Commandos Beach at Barangay Buena Suerte, El Nido, Palawan where several tourist boats were visible before reaching the vicinity of Cadlao Island. The team stopped at Cadlao Lagoon where four (4) tourist boat was observed. One (1) ambulant vendor named Benedicto Royo of Sitio Kiminawit, Barangay Bebeladan, El Nido, Palawan was caught in the area and was given warning by the team.

June 10, 2022; 1:51 PM. From the island of Cadlao, the team passed through Dilumacad Island and approached after a heavy rain the islands of Matinloc and Tapiutan crossing Tapiutan Strait. One (1) small bangka with fisherfolks was observed.

June 10, 2022; 3:35 PM to 11:00 PM. The team standby near the vicinity of Turtle Island and later joined by the team of five (5) of Forest Ranger Arzaga namely FPOs Del Rosario and Moreno and two (2) volunteers. The team then proceeded at coastal area of Barangay Liminangcong, Taytay Palawan and Barangay Bebeladan, El Nido, Palawan passing through Sitio kiminawit of Barangay Bebeladan. During this time several fishing vessels were observed in the area but still no illegal activities recorded. The team arrived at a standby location at Barangay Limanangcong, Taytay, Palawan at about 10:28 PM.

June 11, 2022; 1:00 AM. From Barangay Liminangcong, Taytay Palawan, the team moved to the vicinity of Pinaglugaban and Shimizu Island where several reports of liba-liba fishing is received by the office.

June 11, 2022; 2:12 AM. This time, the team was midway Pinaglugaban Island and Jip Rocks where a certain fishing vessel with multiple lights was being observed allegedly using liba-liba fishing method. However, as the team of FR Arzaga from the other boat moved about 2 minutes away from our vessel, they communicated via hand held radio that they saw an alleged on-going compressor fishing within the vicinity of Jip Rocks and further confirmed the said activity. Our team then proceeded and assisted them as they apprehended the perpetrators. Four (4) civilians, all residents of Barangay Liminangcong, Taytay, Palawan was caught in the act operating compressor fishing activity near the vicinity of Jip Rocks which was identified later as restricted area based on marine zoning of the protected area.

The apprehended individuals was then brought to Divers House at about 3:27 in the morning.

With the result of this activity, the undersigned recommends continuous patrolling and monitoring activity in the area. A separate report on the apprehended compressor fishing activity at CENRO Taytay-El Nido.


