PROCEEDINGS ON ILLEGALLY SOURCE FOREST PRODUCT APPREHENDED AT BRGY. SALCEDO, BANSUD, ORIENTAL

MINDORO

Attached is the transcript of the Minutes of the Administrative Hearing undertaken on the case *Department of Environment and Natural Resources*—versus- Hipolito Rosas and Danay Banay for violation of Section 77 formerly Section 68 Presidential Decree 705 as amended by Executive Order 277 series of 1987 and R.A. 9175. Please be informed that Administrative Hearing was conducted last June 21, 2022 in accordance with Item 2, Section 7 of DAO 97-32 which was attended by respondents, with the following observations:

- 1. Based on the spot report of the Municipal Police of Bansud, they received a tip from a concerned citizen that Danay Banay was seen cutting lumbers at So. Sta. Maria, Salcedo, Bansud, Oriental Mindoro.
- 2. MPS Bansud under the supervision of Police Major Christian A. Marquez went to the area to verify the information. Thereafter, they saw Danay Banay using the chainsaw while cutting the lumbers. They asked him who is the owner of the lumber and whether he has a cutting permit and registration for the use of the chainsaw.
- 3. Danay Banay answered that Hipolito Rosas ordered him to cut the tree. He failed to present any permit or registration.
- 4. Upon verification of Municapal Police of Bansud with Hipolito Rosas, he admitted that he is the owner of the lumbers. He also failed to present any cutting permit.
- 5. During the administrative hearing, Danay Banay admitted that he cut the tree and that he only followed the instruction of Hipolito Rosas. According to him, Hipolito said that everything is okay with the barangay.
- 6. As for Hipolito Rosas, he admitted that he has no cutting permit from the DENR and he only asked for permission to the barangay captain.
- 7. The subject sawn lumbers of Anabiong were turned-over by the apprehending officers to the nearest authorized Seizure Officer pursuant to Section 3 of DAO 97-32.

FINDINGS AND RECOMMENDATIONS:

The undersigned after having reviewed the documents at hand and the statements of the respondents, and the Administrative Hearing conducted, determines that the THREE (3) pieces sawn lumbers (Anabiong species) with a total volume of 98.67 board feet has no legal documents or papers from the DENR to warrant the cutting, gathering and/or possessing the same. This act is in violation of Sec. 77 of PD. 705 as amended.

In view of the foregoing these are the findings and recommendations of the hearing officer:

HIPOLITO ROSAS and **DANAY BANAY.**, respondents for CENRO Case No. 2022- 13 violated Sec. 77 of PD 705 as amended hence:

The THREE (3) pieces sawn lumbers with a total volume of 98.67 and the STIHL chainsaw with serial no. 12301490 **shall be forfeited** in favor of the government and **shall be disposed** in accordance with existing forestry laws, rules and regulations.

This case has been filed to Oriental Mindoro Provincial Prosecution Office with NPS Docket No. N-07a-INQ-22F-00122 for Violation of Sec.77 of PD 705 as amended by E.O.277 and R.A. 9175.


