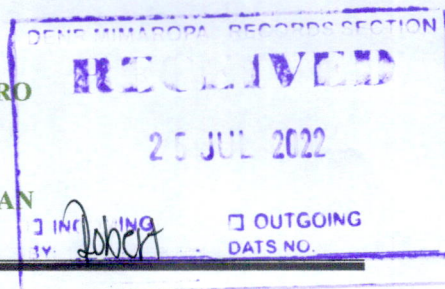

**WHEREAS**, under Executive Order No. 192 (1987), the Department of Environment and Natural Resources (DENR) is the primary government agency responsible for the sustainable development and management of the country's environment and natural resources;

**WHEREAS**, under RA 7160 (Local Government Code of 1991) certain forest management functions of DENR are devolved to the Local Government Unit (LGUs) and LGUs are mandated to share with the national government the responsibility for maintaining the ecological balance within their territorial jurisdiction;

**WHEREAS**, the DENR MIMAROPA and the LGU- Lubang, Occidental Mindoro, with technical assistance of from DENR, Province of Occidental Mindoro, formulated the Municipal Forest Land Use Plan (FLUP) of Lubang, Occidental Mindoro;

**WHEREAS**, the DENR MIMAROPA Regional Director, the PENRO of Province of Occidental Mindoro and the CENRO of Province of Occidental Mindoro reviewed, deliberated and agreed to affirm the Municipal Forest Land Use Plan of Lubang, Occidental Mindoro in an en banc review held in Sangguniang Bayan Session Hall last November 23, 2020;

**WHEREAS**, the Sangguniang Bayan of Lubang, Occidental Mindoro APPROVED and ADOPTED the Municipal Forest Land Use Plan of Lubang, Occidental Mindoro through a Resolution numbered 125 dated December 1, 2020;

**NOW THEREFORE**, on motion of Hon. Imee Elaine G. Abeleda, duly seconded by Hon. Aldous Cesar Lim and Hon. Cris Andrev Valisno it RESOLVED, as it is hereby resolved and approved **RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. MICHAEL L.
