

AN ORDINANCE EXTENDING THE MORATORIUM ON LARGE-SCALE AND SMALL-SCALE MINING IN THE PROVINCE OF ORIENTAL MINDORO, AS PROVIDED FOR UNDER PROVINCIAL ORDINANCE NO. 01-2002 AND PROVINCIAL ORDINANCE NO. 28-2013, RESPECTIVELY, FOR ANOTHER TWENTY-FIVE YEARS OR COVERING THE PERIOD FROM YEARS 2027 TO 2052

WHEREAS, to protect and preserve the environment and natural resources of the Province of Oriental Mindoro, the Sangguniang Panlalawigan of oriental Mindoro enacted (a) *Provincial Ordinance No. 01-2002* titled "An ordinance declaring 25-year moratorium on large-scale mining in the Province of Oriental Mindoro, providing exceptions and penalties therefor", and (b) *Provincial Ordinance No. 28-2013*, titled "An ordinance declaring a 15-year moratorium on small-scale mining activities in the Province of Oriental Mindoro, and providing exceptions and penalties thereof";

WHEREAS, recognizing the importance of imposing mining moratorium in the preservation of the province's remaining ecological soundness for the benefits of all this generation and the generations yet to come, there is a need to extend and sustain said mining moratorium;

NOW THEREFORE, BE IT ENACTED, AS IT IS HEREBY ENACTED BY THE SANGGUNIANG PANLALAWIGAN OF ORIENTAL MINDORO, THAT:

Section 1. Title. This Ordinance shall be known as the “Provincial Ordinance extending the Moratorium on Large-Scale and Small-Scale Mining in the Province of Oriental Mindoro, as provided for under Provincial Ordinance No. 01-2002 and Provincial Ordinance No. 28-2013, respectively, for another twenty-five years or covering the period from years 2027 to 2052”.

Section 2. Extension of Large-Scale and Small-Scale Mining Moratorium. The Large-Scale and Small-Scale Mining Moratorium in the Province of Oriental Mindoro, as provided for under Provincial Ordinance No. 01-2002 and Provincial Ordinance No. 28-2013, respectively, are hereby extended for another twenty-five years or covering the period from years 2027 to 2052.


Section 3. Adopting, Upholding and Sustaining provisions of Provincial Ordinance No. 001-2002 and Provincial Ordinance No. 28-2013. All the provisions stipulated under Provincial Ordinance Nos. 001-2002 and 28-2013, including exceptions and penalties thereof, are hereby adopted, uphold and sustained, and shall remain in full force and effect.

Section 4. Publication/Posting. This Ordinance shall be published or posted in accordance with Section 59 of the Local Government Code of 1991.


Section 5. Effectivity. Upon approval, this Ordinance shall take effect 15 days after publication or posting as required under Section 4 hereof.


