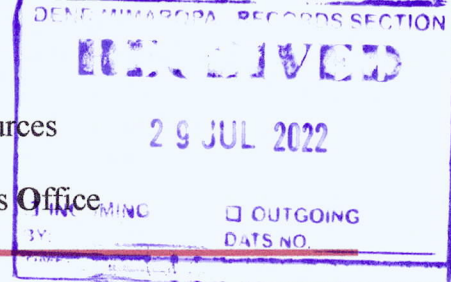

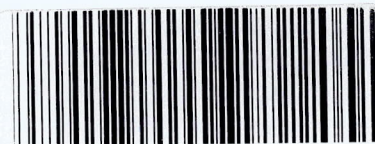
Forwarded is the report of CENRO Socorro, Oriental Mindoro regarding the above subject.



We are pleased to submit the report on wildlife monitoring in air and sea ports located in Municipality of Puerto Galera and in Calapan City, Oriental Mindoro. The monitoring was conducted on July 13-14, 2022.

Based on the report of the concerned personnel of this office, Calapan City airport has no domestic flights as of this writing and only VIP's and Sapphire International Aviation Academy uses the port. While in seaports of Calapan City, and Puerto Galera, all of the respective staff concerned with the matter reported no records of incidents of wildlife traffic from June to April of CY 2022.

In connection with the above cited subject, please be informed that the undersigned personnel conducted wildlife traffic monitoring in Calapan City Air and Sea Ports and Puerto Galera Sea Port for the month of July 2022.

That, on July 13, 2022 the team conducted monitoring in Puerto Galera Seaport located at Brgy. Balatero, Puerto Galera, Oriental Mindoro. During the monitoring we coordinated with OIC, Ma. Elena A. Gozar of Port of Puerto Galera, accordingly there is no incident of transport/arrival of wildlife in the Port on month of June to July, 2022. Also there is no incident of transport/arrival of Wildlife during that day.

That, on July 14, 2022 the team conducted monitoring in Calapan City Seaport located at Brgy. San Antonio, Calapan City, Oriental Mindoro. During the monitoring we coordinated with Lady Guard Kate Aira P. Mulingtapang of Philippine Ports Authority-Port Management Office, Calapan City. Accordingly there was no incident of transport/arrival of Wildlife in the Port for the month of June to July, 2022. Also during the monitoring there is no incident of transport/arrival of Wildlife. That, after on monitoring in seaport we monitored the Calapan City Airport located at Brgy. Suqui, Calapan City, Oriental Mindoro, we coordinated with Admin Marvin Soriquez of Civil Aviation Authority of the Philippines, Calapan City, accordingly there is no domestic flights in the port and only VIPs/Politicians and Sapphire International Aviation Academy uses the Port.

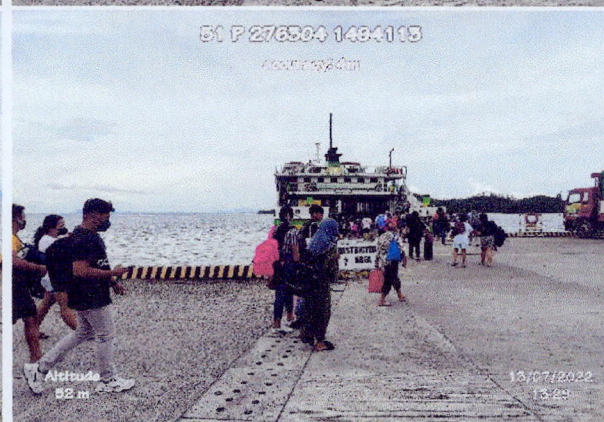

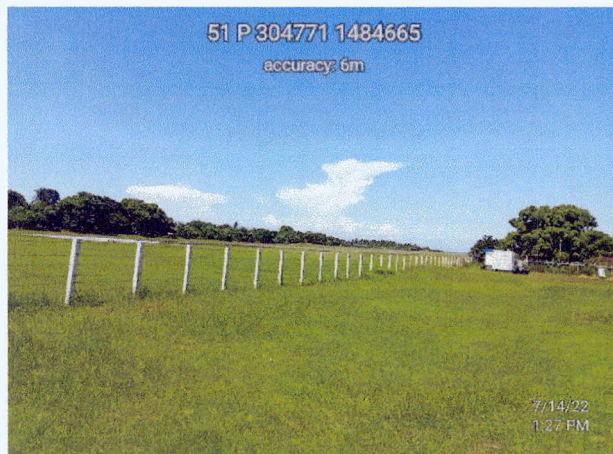
