


Based on the CSW Report, we hereby recommend that all forest products be forfeited in favor of the government.

## COMPLETED STAFF WORK REPORT ON THE APPREHENDED UNDOCUMENTED FOREST PRODUCTS, IN VIOLATION OF SECTION 77 OF PD 705 AS AMENDED BY RA 7161 AND DAO 97-32, SERIES OF 1997

#### I. HISTORY

This is in relation to Administrative Case No. 2021-11-29-01 for violation of Section 77 of PD 705 as amended by RA 7161 and DAO 97-32, series of 1997.

The case was filed against Reynante T. Zurbito.

That on August 11, 2021, at around 11:20 in the evening, the joint force of DENR Enforcement and Monitoring Section, Sablayan Area headed by Forest Ranger Jeffrey B. Vargas, Forest Technician I Rodel S. Capiral and the Sablayan Municipal Police Station apprehended undocumented forest products at So. Tabuk Barangay Buenavista, Sablayan Occidental Mindoro.

During the apprehension, it was found out that the accused was found in possession and custody of 8 pieces of Nato, 11 pieces of Lawaan and 8 pieces of Malugai lumber. He was asked if he have a permit to carry the said lumber and he answered in the negative.

The DENR personnel immediately apprehended the illegal forest products. It was brought to the Office of the Provincial Prosecutor at San Jose, Occidental Mindoro for safekeeping and proper disposition.

The accused was arrested and also brought to the Office of the Provincial Prosecutor at San Jose, Occidental Mindoro for inquest proceeding.

On August 12, 2021, the San Jose Regional Trial Court Branch 45 issued an information against Reynante T. Zurbito for violation of Section 77, PD 705. The case was docketed as Criminal Case No. R-10982.

The administrative hearing for the above apprehended illegal forest products was held on November 29, 2021 at the DENR-CENRO Sablayan Main Office. Forester III Isaias A. Guimod acted as the hearing officer, assisted by EMS Chief Ariston SJ. Ramos. The accused was present and given the chance to explain himself.

#### OBSERVATION/FACTS

- 1. That the operatives of DENR Enforcement and Monitoring Section, Sablayan Area and Sablayan Municipal Police Station conducted an anti-illegal logging operations at So. Tabuk Barangay Buenavista, Sablayan Occidental Mindoro where they apprehended undocumented forest products.
- 2. That during the apprehension, the accused, Reynante T. Zurbito was arrested.
- 3. That during the apprehension, it was found out that the accused was in possession of undocumented forest products. (8 pieces of Nato, 11 pieces of Lawaan and 8 pieces of Malugai lumber)
- 4. That possessing undocumented illegal forest products is a crime under Section 77 of PD 705 as amended by RA 7161.

- That during the Administrative hearing, Mr. Zurbito admitted that he owns a lumberyard and that the apprehended forest products were delivered to him for banca (boat) making.
- 6. That when asked who the owner of the banca was, he said that it is for former Barangay Councilor Alegre.
- 7. That the accused was arrested and brought to the Office of the Provincial Prosecutor at San Jose, Occidental Mindoro for inquest proceeding.
- 8. That an Information was issued against the accused on August 12, 2021. The case was docketed as Criminal case No. R-10982.

#### II. SUMMARY OF ADMINISTRATIVE PROCEEDINGS

It appears that the accused were caught during the illegal logging operations by the joint force of DENR Enforcement and Monitoring Section, Sablayan Area and Sablayan Municipal Police Station. He was caught in possession of undocumented forest products which is in violation of Section 77 of PD 705 as amended by RA 7161.

Section 77 clearly states that possessing forest products without proper documents or permit from the proper authority is a violation under PD 705.

#### III. RECOMMENDATION

Based on the above statement of facts, administrative hearing and criminal case filed, it is hereby recommended that all forest products be forfeited in favor of the government.

That on or about the 11th day of August, 2021, at around 11:20 o'clock in the evening, in Sitio Tabuk, Barangay Buenavista, Municipality of Sablayan, Province of Occidental Mindoro, Philippines, and within the jurisdiction of this Honorable Court, the accused, with intent to gain, did then and there, willfully, unlawfully and feloniously, have in his possession, custody and control eight (8) pieces 2x6x20 Nato lumber, eleven (11) 2x6x16 Lawaan lumber, five (5) pieces 2x6x23 Malugai lumber, and three (3) pieces 2x6x22 Malugai lumber, with total volume of 517 board feet, amounting to THIRTY ONE THOUSAND AND TWENTY PESOS (P31,020.00) Philippine Currency, without any permit or authority from the Secretary of Environment and Natural Resources or his duly authorized representative which is violation of PD 705 as amended, to the damage and prejudice of the Philippine Government.
