MINUTES OF THE COMMUNITY CONSULTATION ON CAVE ASSESSMENT AT BARANGAY LISAP, BONGABONG, ORIENTAL MINDORO

In response to the Cave Assessment activity, this office conducted a Community Consultation for the Assessment of Akliyang Cave under the jurisdiction of the Municipality of Bongabong on June 20, 2022 attended by selected CENRO Personnel, Brgy. Captain, Brgy. Officials, Sitio Leader and Concerned Citizen.

During the said meeting/ consultation meeting, the following were noted and discussed:

- Ecoms I Jerry Manucay started the meeting with an opening prayer for guidance, knowledge and wisdom on the topic that will be discus by the presenter.
- Acknowledgement of participants was conducted by Mr. Dale Alagao before the proper meeting started.
- An opening remarks led by Mr. Joseph Nathaniel Gonzales Tourism Coordinator of the Municipality of Bongabong. He highlights the importance of Cave Assessment. He emphasized that this activity can boost the tourism economy of the Brgy as well as the whole Municipality.
- A presentation on RA 9072 "AN ACT TO MANAGE AND PROTECT CAVES AND CAVE RESOURCES AND FOR OTHER PURPOSES" was discussed by Forester Ivy Macalalag of the Protected Area Management and Coastal Unit. She stated the important of caves and caves resources, she highlight the legal basis that the DENR Office used in assessing and protecting the Cave and Caves Resources on their area of jurisdiction. She also included the fines and penalties that an individual may commit if they will violate the laws on RA 9072.

After the presentation, question and concerned was noted and discussed.

- Mr. Melecio Palermo, Brgy. Captain of Barangay Lisap express his concerned about the owner of the land where the cave is located because it is known to them that the land was belong the a De los Santos and they were afraid that the family will not allowed the team to assess the caves but Mr. Manucay, a GIS specialist assured them that caves belong to the state and not to any individual.
- Mr. Sabong Liway, Sitio Leader of Sitio Akliyang stated that he will guide the team on the Assessment and he will give his full support for the sake of his constituents.
- Mr. Ayas Diaz, Barangay Council suggested that the CENRO should inform them first before the Cave Assessment proper, for them to prepare some necessary things. Forester Macalalag, assured the body that the CENRO Office will send them a letter address to the Barangay Captain beforehand.

- Mr. Pablito Gabayno, Jr, also a councilor of the barangay suggested that the office should also conduct a brief Information, Education and Communication (IEC) Campaign to resident of Akliyang area to inform the IPs about the environmental rules and regulations that the DENR are implementing especially on Management and Conservation of Caves and Caves Resources. It was then agreed by the body.
- There are no problems on their part about the Cave Assessment activity. That infact they are all thankful because the cave will be finally assessed and they are hoping for a best result.
- The conduct of Cave Assessment is scheduled on second week of July, 2022.
- Both team agreed to set a meeting again for any plans after the Cave Assessment.
