On February 05, 2016, a Motion for Reconsideration was filed by Samuel Fernandez and Ruben Cabase. Said motion was denied by then Regional Director Oscar C. Dominguez on June 08, 2016 for being filed out of time.

A Certification dated September 30, 2018 was issued by then Chief, Repurds Section in Concurrent Capacity Dennis B. Valder, Supervising Administrative Officer of DENR-MIMAROPA Regional Office stating that no Nonce of Appeal was filed on the denial of the Motion for Reconsideration, thus, pursuant to Section 7. No. 6 of DAO 97-32, the Orders dated June 27, 2017 and December 14, 2017 are deemed final and executory

WHEREFORE, premises considered, the Orders dated October 22, 2015 and June 08, 2016 are declared FINAL AND EXECUTORY, the CONFISCATED ITEMS are DEEMED PERMANENT PROPERTY of the government, and after ENTRY of this Order into the books of account of PENRO Oriental Mindoro, the following are hereby ORDERED:

Records show that on July 1, 2015 at around 10:30 in the evening elements of the Philippine National Prince (PNP) Rocas Municipal Police apprehended one (1) six-whicher topogram happen with Plate No. VRA \$71 tonded with one hundred forty-five (145) pes, of lumber of tioneline species having an aggregate volume of about 3 499 cum (1,483.7 bd ft.), with an engoured fair market value of PhP 66,771 00; in Baranga; San Mariano, Rosas, Oriental shadors. The driver of the conveyance was identified as Mr. Efren R. Gado and its companion 23 Mr. Roben Cabase, both residents of Bruy, Lisap, Bongabong, Oriental Mindore, Said appreciated items were harded and improveded at DENR-CENRO Roxas, Oriental Windows mider the costody of Property Custodian Elegis C. Ujio for safekeeping. A Seizure Receipt dated Daly 3, 2015 and a Seizure Order dated July 6, 2015 were issued by CENRO Isagani V. Manalili.

The driver failed to present any document for the transport thereof.

#### RESOLUTION

For resolution is the Motion for Reconsideration dated February 5, 2016 filed by Samuel Fernandez, owner of the confiscated gmelina species with an aggregate volume of 3.499 cu.m. and jeepney with Plate No. VRA-871 apprehended in Brgy. San Mariano, Roxas, Oriental Mindoro on July 1, 2015, on the Confiscation Order dated October 22, 2015 issued by this Office, the dispositive portion of which reads:

apprehended One Hundred Forty Five (145) pcs. of lumber of Gmelina species having an aggregate volume of 3.499 cu.m. (1,483.7 bd. Ft.) with an estimated fair market value of PhP 66,771.00 and one (1) unit six wheeler topdown jeepney bearing Plate No. VRA-871, are hereby ORDERED CONFISCATED in favor of the government to be disposed of in accordance with existing DENR Laws, rules and regulations governing the matter. The CENRO concerned is directed to submit regular updates as to the progress of the court case.

SO ORDERED."

After a careful evaluation of the Motion, it was found out that the same was filed out of time. In DAO 97-32, Section 7 thereof provides the period within which to file a Motion for Reconsideration.

A party aggrieved by the original decision may file only one (1) motion for reconsideration within a non-extendible period of fifteen (15) calendar days from receipt of the decision.

Based on record, the movant received the Confiscation Order on December 8, 2015 contrary to his allegation that he only knew of it on December 17, 2015 when he was advised by CENRO personnel to file at once his Motion for Reconsideration. His Motion for Reconsideration was dated January 8, 2016 and was notarized on February 5, 2016.

Assuming for the sake of argument that he only knew of the Confiscation Order on December 17, 2015, the movant had until January 4, 2016 to file said motion considering that January 1 is a holiday and January 2 and 3 fell on Saturday and Sunday, respectively. Hence, his Motion was filed out of time.

Assuming further that the Motion was filed on time, still there is no cogent reason to reverse or revise the assailed Order. It is a settled rule that "a Motion for reconsideration which does not make out a new matter sufficiently persuasive to induce modification of judgment, will be denied (PCIB vs. Escolin, 67 SCRA 202)."

WHEREFORE, premises considered, the Motion for Reconsideration filed by Samuel Fernandez is hereby DENIED.
